Notice is hereby given that the Garden Route District Municipality (GRDM) has requested the competent authority in terms of the National Environmental Management Act (NEMA), 1998 (Act No. 107 of 1998) to regard the Waste Management Licence issued on 05 February 2014 (Licence Number: 12/9/11/L1395/9), as varied on 30 November 2015 and again on 18 July 2017, for the Eden Regional Waste Disposal Facility to be an Environmental Authorisation in terms of NEMA, as provided for by section 24L(4) of NEMA.
