BID CONDITIONS AND INFORMATION

1 Agreement

The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by the Garden Route District Municipality that his/her bid has been accepted.

2 Completion of Bid Documents

- (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
- (b) Bid documents may not be retyped or altered in any way.

3 Alteration or Qualification of Bid

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before the closure date.

4 Authorised Signatory

- (a) A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.

5 Submission of Bid

- (a) The bid must be put in a sealed envelope, or envelopes when the two-envelope system is specified, clearly marked with the bid number, title as well as closing date and time and placed in the **Tender Box at the Garden Route District Municipality by not later than 11h00 on 11 January 2019.**
- (b) Faxed, e-mailed and late bids will not be accepted. Bids may be delivered by hand, by courier, or posted at the bidder's risk and must be received by the deadline specified above, irrespective of how they are sent or delivered.

6 Opening, Recording and Publications of Bids Received.

- Bids will be opened in public immediately after the bid closure date, or at such
- time as specified in the bid documents. If requested by any bidder present,
- names of the bidders, and if practical the total amount of each bid and of any alternative bids will be read out loud.
- Bids received in time recorded and entered in a register which is open for public inspection.

7 Tax Clearance Certificate

- a. A valid original Tax Clearance Certificate must accompany the bid documents.
The onus is on the bidder to ensure that the Garden Route District Municipality has an original Tax Clearance Certificate on record and obtain confirmation from the Supply Chain Management Unit of the Garden Route District Municipality.
- b. Bids not supported by a valid original Tax Clearance Certificate, as an attachment to the bid documents will be invalidated.
- c. In bids where consortia/joint ventures/sub-contractors are involved, each party must submit a separate valid original Tax Clearance Certificate.

8 Evaluation of Bids

Bids will be evaluated in terms of their responsiveness to the bid specifications and requirements as well as such additional criteria as set out in the bid documents.

9 Acceptance or Rejection of a Bids

The Garden Route District Municipality reserves the right to withdraw any invitation to submit a bid and/or to re-advertise or to reject any bid or to accept a part of it. The Garden Route District Municipality does not bind itself to accepting the lowest bid.

10 Registration on Accredited Supplier Database

It is expected of all prospective service providers who are not yet registered on the Central Supplier Database to register online (www.csd.gov.za) and verify their company information at Garden Route District Municipality Database Department. The Garden Route District Municipality reserves the right not to award proposals to prospective suppliers who are not registered on the CSD (Central Supplier Database).

12 Stamp and Other Duties

The successful bidder will be liable for all duties and costs on legal documents resulting in the establishment of a contract and for the surety and retentions.

13 Language of Contract

The contract documents will be compiled in English and the English versions of all referred documents will be taken as applicable.

14 Procurement Policy

Bids will be awarded in accordance with the Preferential Procurement Regulations, 2017 pertaining to the Preferential Procurement Policy Framework Act, No 5 of 2000.

15 Expenses Incurred in Preparation of Bid

The Garden Route District Municipality shall not be liable for any expenses incurred in the preparation and submission of the bid.

16 Wrong Information Furnished

Where a contract has been awarded on the strength of the information furnished by the bidder which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Garden Route District Municipality may, in addition to any other legal remedy it may have, recover from the contractor all costs, losses or damages incurred or sustained by the Municipality as a result of the award of the contract.

17 Validity Period

Bids shall remain valid for 90 days after the bid closure date.

18 General and Special Conditions of Contract

The General Conditions of Contract as well as any Special Conditions of Contract that may form part of this set of bid documents will be applicable to this bid in addition to the conditions of bid.

19 Municipal Rates, Taxes and Charges

TERMS OF REFERENCE:

INVITATION TO BID FOR GARDEN ROUTE DISTRICT MUNICIPALITY AUTOMATED INTEGRATED RISK MANAGEMENT & INTERNAL AUDIT SOFTWARE SYSTEM

BACKGROUND

In this current climate demands for governance and transparency, the challenges to Internal Audit and Risk Management have never been greater. To cost –effectively address these increasing demands, a need has arisen for comprehensive, easy-to-use tools and systems that streamline Audit and Risk Management processes, to improve productivity, increase coordination throughout governance participants and ensure efficiency and accurate reporting. This integration within a comprehensive and unified set of integrated software solution helps to ensure that Internal Audit and Risk Management can work together, to fully leverage each other's strengths and also foster combined assurance. The current processes are manual, making it difficult for Risk Management and Internal Audit to execute their functions optimally. It is against this background that **Garden Route District Municipality's** Internal Audit and Risk Management sections sought to procure an automated integrated Internal Audit and Risk Management software solution.

The Garden Route District municipality is also looking into procuring a District wide system that can be used by all Local municipalities within the District. This will help in improving our coordination efforts as the district. A uniform system will also allow sharing of information, challenges and efficiencies amongst the Municipalities with our district.

It is therefore requested that service providers tender on two options. The options being as follow:

Option 1: System for Garden Route District Municipality

Option 2: System for the District as well as for B Municipalities

Technical ICT Requirements:

Our ICT functionality is as follows:

- Hyper-V Virtual environment
- Windows Server 2012 Domain
- SQL 2016 Server available for Database
- Collaborator Workflow for Business Processes
- Full back up and Disaster Recovery infrastructure
- Owns Public IP's for publishing and hosting

***The service provider is also required to submit with the tender documents their IT requirements for their respective system.**

USER REQUIREMENTS

The Integrated software should include the following outputs:

Service providers must provide an ERM software solution (preferably on-site) to support the documenting, tracking, measurement, management, and reporting of enterprise risks. The service provider must also provide training on the use of the software. It must be clearly indicated if the proposed solution can be hosted locally or offsite. The supplied software must be the latest version on the general release. Installation of software for all licensed users and access for all other employees in the organisation to do the following:

- Capturing and Updating of risks
- Rating of risks
- Capturing and Updating of controls
- Capturing action plans against identified risks, audit findings, incidents etc.
- Update progress on action plans
- View all risks and actions allocated to the user
- Risk Dashboard for Executive Management

The software remain the property of Garden Route District Municipality even after the tender has lapsed for continuous use by the municipality.

Garden Route District Municipality will use the System to help assess enterprise risk quantitatively and qualitatively, as well as all internal audit related processes. In addition to the broad array of risk (financial, legal, operational, etc.) for measurement in the System, Garden Route District Municipality may wish to use the System to help manage its compliance e.g. Financial, Legal and Health, Safety & Environment (HSE) risks / exposures.

Using the System, Garden Route District Municipality will execute and oversee activities necessary to protect organisational assets per our risk management framework (RMF) aligned with the COSO and or ISO31000 frameworks, as well as all internal policies and regulations. For Internal Audit, the system will be used to facilitate Internal Audit activities to be performed in compliance with the International Standards for the Professional Practice of Internal Auditing as issued by the Institute of Internal Auditors.

Tenderers must be prepared to give a demonstration of the proposed solution, at no cost to Council, when requested to do so.

System Requirements:

- Tried and tested automated integrated Risk Management and Internal Audit software solution
- The system should be based on universally accepted best –practice methodology, to enable **Garden Route District Municipality** to adopt and be compliant with frameworks such as COSO, ISO, KING IV, the institute of Internal Auditors' IPPF audit standards etc.
- Combined planning of all Internal Audit and Risk Management assurance activities within **Garden Route District Municipality**.

In the case of a Close Corporation, a resolution from the members that the person who is appointed to sign the tender and SLA document is authorized to act on behalf of the Close Corporation. The full names, identity number and his/ her capacity must be included in the resolution.

A TRUST

A certified copy of the Trust deed (document) as well as a letter of authority in the case of business trust.

A PARTNERSHIP

A certified copy of the Partnership Agreement.

A SOLE PROPRIETOR

A certified copy of the Owner's ID document.

In all cases, a valid Tax Clearance certificate is required.

Where necessary certified copies of other relevant registration certificates pertaining to the business as required by legislation.

The above documentation did not include necessarily all the documentation that may be needed by the Supply Chain department which must also be requested.
