**Important note:** A Valid original Tax Certificate and certified copies of directors and owners' identity documents must be submitted with the documentation.

**It will be required from successful tenderers to register on the Central Supplier Database (CSD).**

#### VAT must be included in all prices.

The Council reserves the right to accept any tender or part thereof, and with the increase in price of any of the commodities, its purchases of those commodities from the specific tenderer will be considered and to determine the period of tenders to be awarded.

Tenders will not be considered should the prerequisites not be met.
