## BID CONDITIONS AND INFORMATION

### 1 Agreement

The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by the Eden District Municipality that his/her bid has been accepted.

### 2 Completion of Bid Documents

- (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
- (b) Bid documents may not be retyped or altered in any way.

### 3 Alteration or Qualification of Bid

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before the closure date.

### 4 Authorised Signatory

- (a) A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.

### 5 Submission of Bid

- (a) The bid must be put in a sealed envelope, or envelopes when the two-envelope system is specified, clearly marked with the bid number, title as well as closing date and time and placed in the **Tender Box at the Eden District Municipality by not later than 11h00 on 14 September 2018.**
- (b) Faxed, e-mailed and late bids will not be accepted. Bids may be delivered by hand, by courier, or posted at the bidder's risk and must be received by the deadline specified above, irrespective of how they are sent or delivered.

### 6 Opening, Recording and Publications of Bids Received.

- Bids will be opened in public immediately after the bid closure date, or at such
- time as specified in the bid documents. If requested by any bidder present,
- names of the bidders, and if practical the total amount of each bid and of any alternative bids will be read out aloud.
- Bids received in time recorded and entered in a register which is open for public inspection.

### 7 Tax Clearance Certificate

- a. A valid original Tax Clearance Certificate must accompany the bid documents. The onus is on the bidder to ensure that the Eden District Municipality has an original Tax Clearance Certificate on record and obtain confirmation from the Supply Chain Management Unit of the Eden District Municipality.
- b. Bids not supported by a valid original Tax Clearance Certificate, as an attachment to the bid documents will be invalidated.
- c. In bids where consortia/joint ventures/sub-contractors are involved, each party must submit a separate valid original Tax Clearance Certificate.

### 8 Evaluation of Bids

Bids will be evaluated in terms of their responsiveness to the bid specifications and requirements as well as such additional criteria as set out in the bid documents.

### 9 Acceptance or Rejection of a Bids

The Eden District Municipality reserves the right to withdraw any invitation to submit a bid and/or to re-advertise or to reject any bid or to accept a part of it. The Eden District Municipality does not bind itself to accepting the lowest bid.

### 10 Registration on Accredited Supplier Database

It is expected of all prospective service providers who are not yet registered on the Central Supplier Database to register online ([www.csd.gov.za](http://www.csd.gov.za)) and verify their company information at Eden District Municipality Database Department. The Eden District Municipality reserves the right not to award proposals to prospective suppliers who are not registered on the CSD (Central Supplier Database).

**12 Stamp and Other Duties**

The successful bidder will be liable for all duties and costs on legal documents resulting in the establishment of a contract and for the surety and retentions.

**13 Language of Contract**

The contract documents will be compiled in English and the English versions of all referred documents will be taken as applicable.

**14 Procurement Policy**

Bids will be awarded in accordance with the Preferential Procurement Regulations, 2017 pertaining to the Preferential Procurement Policy Framework Act, No 5 of 2000.

**15 Expenses Incurred in Preparation of Bid**

The Eden District Municipality shall not be liable for any expenses incurred in the preparation and submission of the bid.

**16 Wrong Information Furnished**

Where a contract has been awarded on the strength of the information furnished by the bidder which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Eden District Municipality may, in addition to any other legal remedy it may have, recover from the contractor all costs, losses or damages incurred or sustained by the Municipality as a result of the award of the contract.

**17 Validity Period**

*Bids shall remain valid for **90 days** after the bid closure date.*

**18 General and Special Conditions of Contract**

The General Conditions of Contract as well as any Special Conditions of Contract that may form part of this set of bid documents will be applicable to this bid in addition to the conditions of bid.

## TERMS OF REFERENCE

### SCOPE:

- Vehicle is to be a heavy duty vehicle (HDV) with a load capacity not exceeding 8 tons.
  - The vehicle shall be designed for operation using a maximum crew of three (3) persons including the driver, and shall be equipped to perform the specified tasks.
  - The vehicle shall have 4x4 and differential lock capabilities.
  - The vehicle is to be white in colour.
  - Sign writing shall be as per specifications and is to include specific striping.
  - Vehicle is to be fitted with a warning light system that is incorporated with an approved siren unit.
  - Vehicle to be fitted with a winch, bulbar and a theft preventive system.
  - Vehicle must have a service plan included.
  - The wet-end section will be a modular design allowing the tank section, the rear discharge section and the storage to be removed individually.
  - Vehicle is to be supplied with factory warranties.
  - Vehicle is to be supplied with a service and maintenance plan.
  - All modifications and fabricated components to be supplied with a minimum of a 12 month guarantee.
2. Engine requirements and performance characteristics:
- The vehicle, shall be of the diesel driven type
  - The vehicle is to have a minimum engine capacity of 5.8 liters.
  - The four wheel drive and diff lock capability shall be fully engaged from the cab of the vehicle.
  - A Power Take Off drive must be fitted to enable pump operations using the main engine.
  - The vehicle shall be fitted with a fuel tank with a minimum capacity of 180 litres and with a lockable fuel cap.
3. Electrical system:
- Supplier approved, alternative 24V battery power supply system (dual) with change over switch and connected to the vehicle charging circuitry for both battery banks.
  - Main electrical system shall have a cut off switch.
4. Dimensions:
- Any chassis length alteration must carry the Vehicle Manufacturer guarantees and certifications.
  - The ground clearance should not be less than 390mm front and rear.
  - Chassis length of not more than 4.5 (between wheel centers)
5. Brakes
- Vehicle to incorporate ABS braking system.
6. Tyres
- All tyres shall be of local manufacture in accordance with SABS 1550.
  - Vehicle to be fitted with all terrain tyres.
7. Design and Construction:
- The manufacture of the unit shall be in accordance with the requirements outlined in this document and shall comply with the following:
- 7.1. Cab Assembly
- Vehicle Cab shall be a single cab with crew capacity of maximum three people including the driver. (No separate crew cab)
  - The cab shall be of metal construction. Some covers or design parts may be manufactured from other material.
  - The front seats shall be adjustable for the occupants comfort.
  - The cab's side windows shall be manually operated from inside the cab. All glass shall be safety glass.
8. Body work and storage space:
- The design of the vehicle shall take into consideration the need to ensure that all equipment must have a dedicated storage location whether loose or fixed and will remain in a secured position during travel.
  - All storage compartments must be lockable.
  - All doors must have a positive "open-position" retraining system.
  - All compartment floors must be rubberised.
  - Dedicated storage compartment for fuel closely located to the pumps. Drip torches are classed as fuel containers and stored in this compartment.
  - All storage space shall be dust proof but also allow for easy drainage when washing out the compartment.
  - Storage for lay flat canvas hoses that is drainable must be provided that can accommodate up to 4 x 25mm x 30M and 4 x 38mm x 30M lay flat canvas hoses.



- LED must be installed inside each storage compartment, switched by door opening or on driver console in the cab except for the fuel storage compartment.
- A locker with a separate key for the driver to lock away the vehicle specific equipment e.g. Jack, wheel spanner, triangles, etc. must be supplied.
- Storage space is to be able to accommodate and make provision for the following:
  - Beaters – 2m length
  - Brush-cutters – 2m length
  - Hydrant equipment – From 1m to 2m
  - All other similar length equipment is to be stored in the lockers required for the above.
  - SCBA's to be in a separate locker with storage facility to render it upright at all times.
  - Branches to be in a locker that renders it upright at all times.
  - Water supply equipment locker
  - Locker for 2 knapsacks
  - Lockers for loose equipment.
  - Locker for the storage of 100L drinking water
  - Locker for motorized equipment.

#### 9. Bulbar and winch

- A mild steel, heavy duty, front mount bull-bar must be fitted (design to allow quick and easy cab tilt or fluid replenishment access if the cab tilts forward).
- Matt black in colour.
- A Suitable electric winch with a 30 m cable for self-recovery to be mounted on the bullbar.(12v/24v 8000Kg).
- Control of the electric motor shall be by means of a handheld switch with forward, neutral and reverse positions. The switch shall be located at the end of a minimum 5m electric cord that plugs into receptacle near the winch location.
- A legal, hinged rear under-run bumper designed to give-way on contact when the vehicle is in a forward motion

#### 10. Theft Preventive Systems: Immobiliser

- Vehicles shall be fitted with an engine immobiliser and alarm system.
- The system shall be coupled to the ignition system of the vehicle and shall be automatically activated when the engine of the vehicle is switched off.

#### 11. Lights and Warning Light system

The system shall comprise of the following:

- A 1.4m light bar with 4 front, 4rear and 2 corner LED panels shall be installed.
- System to be a red light system
- Control panel to be centrally mounted in the front of vehicle cab for use by both driver and crew.
- 2 Flashing LED panels shall be fitted to the rear.
- 2 Spot lights to be attached to the rear of the vehicle for visibility during night operations.
- Reverse alarm to be integrated into reverse gear selection if not a standard feature of the vehicle.
- LED working lights at pumps, reels, working platforms and access areas. Both sides and the rear of the wet end must be sufficiently lit up.

#### 12. Siren Unit

- To include a 100W Siren Amplifier and PA system
- Is to be of the touch control type.
- Is to have the wail and yelp sounds included.

#### 13. Water tank and wet end structure/plumbing:

- Tank capacity to be a minimum of 5000 litres and be able to be within the maximum permissible load for the chassis once mounted.
- Bottom drainage for complete water usage must be included.
- Must be constructed of an acceptable and approved material.
- Water baffles must be installed or placed inside the tank/s.
- Overhead filling aperture must be included for slosh spillage prevention design and workable from a designed working platform < 2m above ground level for a person 1.7 m tall.
- Vented manhole for interior inspection & maintenance 450 mm round or square (either the filler or dedicated manhole)
- Two main tank level indicators are required: one in the cab visible to the driver and the other on the wet end visible while standing on the ground. Minimum indicators required are; Full, 50%, 30% & reserve with a buzzer.
- Ladders to be installed at the rear and front of the wet-end for access onto the floorboard.
- Grab handle and flared punched ladder rungs for non slip surfaces for safe access
- 2 x 25mm gravity fed knapsack filler outlets must be installed, one on each side of the vehicle.

#### 15. Pumps and Plumbing:

- 1 x Main Pump with delivery of at least 700lt / min @ 12 Bar (or similar) - close coupled to the hydraulic drive and powered with a PTO.(Pump spares must be readily available) and must include:
  - ✓ Open loop system with necessary pressure relief
  - ✓ Air cooled oil tank of sufficient capacity
  - ✓ Inline hydraulic filtration and cooling is required
- A suction priming device must be provided for supply to the main pump and back-up pump.
- Suction pump must be positioned for drafting water from open source.
- 6 meter, 65mm suction hose to be provided for drafting purposes and to be compatible with the suction pump.

- Suction hose to have an aluminium foot valve, camlock couplings and strainer and must be supplied and housed in a storage pipe or similar to keep hose lengths straight.
- Suction hose to be divided into 3 meter sections.
- Electric start power supply for the main pump must be provided from its own battery.
- A back-up pump must be installed on open space and not inside a locker.
- Back-up pump must be at least a twin stage pump close coupled to a petrol or diesel driven engine of at least 13 Horse Power with manual & electric start
- A common delivery manifold design is to be installed to distribute to pressure outlets and to receive water from the pumps.
- The manifold is to have connections to the 2 hose-reels, the attack line, the vehicle protection system and from the main pump, the back-up pump and the suction pump.
- The manifold is to have a delivery to effect cooling from the main pump and the back-up pump to the tank.
- Delivery lines will be fitted with instantaneous couplings and quick release coupling where required.
- Non-return valve to be fitted to the pump discharge.
- Pressure relief valve to be integrated to protect against excessive pressure causing damage
- All plumbing is to be protected against chaffing on bodywork and chassis
- No plumbing will protrude further than the bodywork extremities to prevent damage and injury
- Strainers must be installed to protect pumps (easy access for maintenance)
- A pressure gauge is to be fitted onto delivery manifold to monitor pump delivery performance
- By-pass valve for tank-fill must be installed.
- Pull start mechanisms must be freely accessible for comfortable operation without having to remove frame work or plumbing and mechanism securing bolts
- All pumps, engines and hydraulic motors to be positioned on appropriate AV rubber mountings and must have easy and quick access for exchange and maintenance
- All exposure of V belts, pulleys and mechanical drives must be completely guarded to prevent injury.

#### 16. Hose reels:

- 2 x heavy duty reels designed to eliminate kinks on the initial reel rotation after connection must be installed (for low pressure systems)
- Crank-handle recovery feature is required (handle removable)
- Reel locking mechanism to be installed to prevent unwinding during travel.
- Hose reels must be manual wind up
- 2 x 60m of 25mm (20Bar rated) rubber hose for HV - LP delivery with quick release couplings on both ends (detachable from the reel)

#### 17. Vehicle protection

- Vehicle protection system to draw water from the tank.
- Nozzles to be angled to wet the vehicle directly, with water running down the roof and bodywork.
- Nozzles to be spaced to enable a continuous curtain of water on the cab and body. System can be manually activated.
- Wheel protection nozzles supplied at one per outside wheel - 20mm brass 180° @ ± 20lt / min
- Front & rear bumper spray nozzles - 20mm brass 180° @ ± 50lt / min for emergency tracer and road wetting.
- Cab protection nozzles - 20mm brass 180° @ ± 20lt / min
- Manual control valves for the applications are to be supplied as an integral part of the water tanker facility.
- Minimum number of valves for ease of operation and fitted close to the appropriate outlet to minimise operational confusion.
- ¼ turn ball valves (not plastics)

#### 18. Loose equipment to be provided:

- 2 x 25mm quick release coupling nozzles
- 2 x steel wheel chocks (matching the vehicle wheel circumference)
- 2 x 9 kg fire extinguisher with brackets.
- 1 x tool slide-out-tray containing: 1 x 250 mm shifting spanner, 1 x 200 mm pliers with wire shearing capability, 2 x 10 x 200 screwdriver (flat and star point), 1 x 300 mm water pump pliers, 1 x spark plug spanner, 1 x 10mm x 150mm T-socket (recoil starter), 1 x each ring-set spanners size: 10, 12, 13, 17 & 19.

#### 19. Critical notes:

- Fully laden weight of the fire fighting unit, including all expected crew equipment is to be stated on the quotation. This weight may not exceed the vehicle's permissible GVM.
- Modular design principles will have preference to facilitate bolt-on/off replacement
- Recovery points constructed on the front and rear, anchored to the manufacturers mounted points/ vehicle chassis

#### **1. Definitions**

1. The following terms shall be interpreted as indicated:
  - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
  - 1.2 "Contract" means the written agreement entered into between the purchaser and the provider, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
  - 1.3 "Contract price" means the price payable to the provider under the contract for the full and proper performance of his contractual obligations.
  - 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
  - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
  - 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
  - 1.7 "Day" means calendar day.
  - 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
  - 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
  - 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the provider bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
  - 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.

Should the supplier fail to respond within the stipulated fourteen (14) days the purchaser may regard the supplier as having no objection and proceed with the restriction.</p> <p>24.5 Any restriction imposed on any person by the purchaser will, at the discretion of the purchaser, also be applicable to any other enterprise or any partner, manager, director or other person who wholly or partly exercises or exercised or may exercise control over the enterprise of the first-mentioned person, and with which enterprise or person the first-mentioned person, is or was in the opinion of the purchaser actively associated.</p> <p>24.6 If a restriction is imposed, the purchaser must, within five (5) working days of such imposition, furnish the National Treasury, with the following information:</p> <p>(i) the name and address of the supplier and / or person restricted by the purchaser;</p> <p>(ii) the date of commencement of the restriction;</p> <p>(iii) the period of restriction; and</p> <p>(iv) the reasons for the restriction.</p> <p>These details will be loaded in the National Treasury's central database of suppliers or persons prohibited from doing business with the public sector.</p> <p>24.7 If a court of law convicts a person of an offence as contemplated in sections 12 or 13 of the Prevention and Combating of Corrupt Activities Act, No 12 of 2004, the court may also rule that such person's name be endorsed on the Register for Tender Defaulters. When a person's name has been endorsed on the Register, the person will be prohibited from doing business with the public sector for a period not less than five years and not more than 10 years. The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.</p>
<b>25. Anti-dumping and countervailing duties and rights</b>	25.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. No mediation in respect of this matter may be commenced unless such notice is given to the other party.</p> <p>28.3 Should it not be possible to settle a dispute by means of mediation, it may be settled in a South African court of law.</p> <p>28.4 Notwithstanding any reference to mediation and/or court proceedings herein,            (a) the parties shall continue to perform their respective obligations under the contract unless they otherwise agree; and            (b) the purchaser shall pay the provider any monies due the provider for goods delivered and / or services rendered according to the prescripts of the contract.</p>
<b>29. Limitation of liability</b>	<p>29.1 Except in cases of criminal negligence or wilful misconduct, and in the case of infringement pursuant to Clause 6;            (a) the provider shall not be liable to the purchaser, whether in contract, tort, or otherwise, for any indirect or consequential loss or damage, loss of use, loss of production, or loss of profits or interest costs, provided that this exclusion shall not apply to any obligation of the provider to pay penalties and/or damages to the purchaser; and</p> <p>(b) the aggregate liability of the provider to the purchaser, whether under the contract, in tort or otherwise, shall not exceed the total contract price, provided that this limitation shall not apply to the cost of repairing or replacing defective equipment.</p>
<b>30. Governing language</b>	30.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.
<b>31. Applicable law</b>	31.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified.
<b>32. Notices</b>	<p>32.1 Every written acceptance of a bid shall be posted to the provider concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice.</p> <p>32.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.</p>
<b>33. Taxes and duties</b>	<p>33.1 A foreign provider shall be entirely responsible for all taxes, stamp duties, license fees, and other such levies imposed outside the purchaser's country.</p> <p>33.2 A local provider shall be entirely responsible for all taxes, duties, license fees, etc., incurred until delivery of the contracted goods to the purchaser.</p> <p>33.3 No contract shall be concluded with any bidder whose tax matters are not in order. Prior to the award of a bid SARS must have certified that the tax matters of the preferred bidder are in order.</p>
<b>34. Transfer of contracts</b>	34.1 The contractor shall not abandon, transfer, assign or sublet a contract or part thereof without the written permission of the purchaser.
<b>35. Amendment of contracts</b>	35.1 No agreement to amend or vary a contract or order or the conditions, stipulations or provisions thereof shall be valid and of any force unless such agreement to amend or vary is entered into in writing and signed by the contracting parties. Any waiver of the requirement that the agreement to amend or vary shall be in writing, shall also be in writing.
