1 Agreement

The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by the Eden District Municipality that his/her bid has been accepted.

2 Completion of Bid Documents

- (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
- (b) Bid documents may not be retyped or altered in any way.

3 Alteration or Qualification of Bid

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before the closure date.

4 Authorised Signatory

- (a) A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.

5 Submission of Bid

- (a) The bid must be put in a sealed envelope, or envelopes when the two-envelope system is specified, clearly marked with the bid number, title as well as closing date and time and placed in the **Tender Box at the Eden District Municipality by not later than 11h00 on 05 September 2018.**

6 Opening, Recording and Publications of Bids Received.

- Bids will be opened in public immediately after the bid closure date, or at such
- time as specified in the bid documents. If requested by any bidder present,
- names of the bidders, and if practical the total amount of each bid and of any alternative bids will be read out aloud.
- Bids received in time recorded and entered in a register which is open for public inspection.

7 Tax Clearance Certificate

- A valid original Tax Clearance Certificate must accompany the bid documents.
 The onus is on the bidder to ensure that the Eden District Municipality has an original Tax Clearance Certificate on record and obtain confirmation from the Supply Chain Management Unit of the Eden District Municipality.

13 Language of Contract

TERMS OF REFERENCE

Scope:

The garment is designed to be worn by hazardous materials responders (fire-fighters), providing adequate protection at incidents where there is a chemical release. The hazardous materials suits have to adhere to the following criteria: Standards and Design:

Adhere to EN 943

"EN 943-2. Standard on chemical protective suits for emergency responders and fire fighters."

Or

Adhere to NFPA 1991. "Standard on Vapour-Protective Ensembles for Hazardous Materials Emergencies."

Certification

- 1) The provider must produce and include certification stating compliance to standards for all material and construction used in the manufacturing of the required hazardous materials protective clothing.
- The material specifications standards must be stated on the label, which must be attached to jacket as well as the trousers.

3. Level A - Suits.

- Encapsulated Level A garment design for highest level of protection from liquid splash and vapour/gas exposures for both the wearer and respiratory equipment
- Must be able to provide a broad range of chemical protection.
- Double taped seams to provide strong chemical resistance against heavy liquid splashes. A sewn seam covered, both inside and outside of garment with compatible chemical-resistant material by heat-sealing.
- Expanded face shield to provide wide 220 degree viewing angle. EX face shield is three-layer laminate composed of 40 mil PVC/5 mil Teflon® /20 mil PVC
- Rear entry design to keep closure away from direct contact with frontal chemical exposure and provides ability to change air bottle on SCBA without removing the entire garment
- Expanded back to accommodate self-contained air breathing apparatus (SCBA)
- · Vapour tight zipper. Zipper to cover the entire upper body to increase garment opening and aid donning and doffing
- Storm flap to cover zipper which can be secured by the wearer with rugged hook and loop material to prevent intrusion at zipper
- · Attached internal gloves composed of five layer laminate film for a broad range of chemical protection
- Butyl B 161 gloves, to provide mechanical and physical durability to help protect inner glove. Gloves shall be attached with vapour tight ring and clamp system and must be replaceable.
- Shall have integrated socks composed of garment material
- Shall have attached flaps to cover boot tops to help reduce potential for liquid intrusion
- Shall have two exhaust valves to release higher pressure inside encapsulating garments while simultaneously helping to
 prevent inward leakage of external vapours or particles into the garment. One-way valves for positive pressure and open
 on demand. Valves that include splash covers made of barrier material to help prevent liquid intrusion. Valves to be
 located on left back of head and right lower back.
- Shall have internal adjustable waist belt system for support and improved fit.
- Shall have additional barrier material sewn at knees and over taped parts for added abrasion resistance when kneeling or crawling
- Each suit shall have a unique serial number and is fully tested at time of manufacture including positive air pressure integrity testing per ASTM F1052.

5. Level B - Suits

- One Piece Level B reusable suit which can be used with SCBA, compressed airline or filter mask.
- Must be able to provide a broad range of chemical protection.
- Elasticised face, wrists and ankle for optimal fit.
- Thumb loops to prevent sleeves from sliding up.
- Zipper to cover the entire upper body to increase garment opening and aid donning and doffing
- Storm flap to cover zipper which can be secured by the wearer with rugged hook and loop material to prevent intrusion at zipper
- The suit must be constructed with liquid-tight heat-sealed seams.
- Shall have integrated socks composed of garment material
- Shall have attached flaps to cover boot tops to help reduce potential for liquid intrusion

5. General

- The approved supplier must provide the required personal protective equipment for the period of one year only.
- The Manufacturer must offer a repair service if so required by the council at a material cost only basis.



General Conditions of Contract

1. Definitions

- 1. The following terms shall be interpreted as indicated:
- 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2 "Contract" means the written agreement entered into between the purchaser and the provider, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3 "Contract price" means the price payable to the provider under the contract for the full and proper performance of his contractual obligations.
- 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7 "Day" means calendar day.
