The purpose of the tender is to appoint a service provider for the fencing of Garden Route DM's Roads Depot in Mission Road George.

2. DEFINITION

As defined in the tender specifications.

Contractors must have a CIDB grade of 3 or higher and must be registered in the SQ category. Proof of registration must be included in tender.

7. SPECIFICATIONS

- Palisade must be 2.4 meters above ground except for the section at the entrance above the existing wall.
- 76x76x1.6 mm tube post
- 3mm post bracket to fix cross bar to post
- 50x2.5 mm Rolled Trident pale
- 40x40x3.0 mm crossbar. Three crossbars should be used, one each at top and bottom and the third should be place one third up from bottom
- A post cap should be fitted on the post
- All nuts and bolts should be anti-vandal nuts and round bolts
- Post should be at 3 meters spacing and cast into 600x300x300mm 25 MPa concrete
- Distance between pales should be 115mm and a total of 17 pales at 165mm centre to centre should be between posts.
- All palisade material should be hot dip galvinised.
- All hot dip galvanizing shall be carried out in accordance with SABS 934 and SABS 763 where applicable, including preparation for galvanizing.
- The materials shall be free from slag or coarse laminations, fine fissures and rolled-in impurities.
- Repairs to galvanized coatings will not be accepted.
- Items damaged will need to be re-galvanized.
- The SABS requirement for uniformity shall apply.
- Old fencing material must be removed from site and will become the property of the successful tenderer
- A safety plan must be provided by successful tenderer and must be approved by Garden Route DM before any work starts



General Conditions of Contract

1. Definitions

- 1. The following terms shall be interpreted as indicated:
- 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2 "Contract" means the written agreement entered into between the purchaser and the provider, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3 "Contract price" means the price payable to the provider under the contract for the full and proper performance of his contractual obligations.
- 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7 "Day" means calendar day.
- 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
- 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
