1 Agreement

The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by the Garden Route District Municipality that his/her bid has been accepted.

2 Completion of Bid Documents

- (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
- (b) Bid documents may not be retyped or altered in any way.

3 Alteration or Qualification of Bid

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before the closure date.

4 Authorised Signatory

- (a) A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.

5 Submission of Bid

- (a) The bid must be put in a sealed envelope, or envelopes when the two-envelope system is specified, clearly marked with the bid number, title as well as closing date and time and placed in the **Tender Box at the Garden Route District Municipality by not later than 11h00 on 03 June 2019.**
- (b) Faxed, e-mailed and late bids will not be accepted. Bids may be delivered by hand, by courier, or posted at the bidder's risk and must be received by the deadline specified above, irrespective of how they are sent or delivered.

6 Opening, Recording and Publications of Bids Received.

- Bids will be opened in public immediately after the bid closure date, or at such
- time as specified in the bid documents. If requested by any bidder present,
- names of the bidders, and if practical the total amount of each bid and of any alternative bids will be read out loud.
- Bids received in time recorded and entered in a register which is open for public inspection.

7 Tax Clearance Certificate

- a. A valid original Tax Clearance Certificate must accompany the bid documents. The onus is on the bidder to ensure that the Garden Route District Municipality has an original Tax Clearance Certificate on record and obtain confirmation from the Supply Chain Management Unit of the Garden Route District Municipality.
- b. Bids not supported by a valid original Tax Clearance Certificate, as an attachment to the bid documents will be invalidated.
- c. In bids where consortia/joint ventures/sub-contractors are involved, each party must submit a separate valid original Tax Clearance Certificate.

8 Evaluation of Bids

Bids will be evaluated in terms of their responsiveness to the bid specifications and requirements as well as such additional criteria as set out in the bid documents.

9 Acceptance or Rejection of a Bids

The Garden Route District Municipality reserves the right to withdraw any invitation to submit a bid and/or to re-advertise or to reject any bid or to accept a part of it. The Garden Route District Municipality does not bind itself to accepting the lowest bid.

10 Registration on Accredited Supplier Database

It is expected of all prospective service providers who are not yet registered on the Central Supplier Database to register online (www.csd.gov.za) and verify their company information at Garden Route District Municipality Database Department. The Garden Route District Municipality reserves the right not to award proposals to prospective suppliers who are not registered on the CSD (Central Supplier Database).

12 Stamp and Other Duties

The successful bidder will be liable for all duties and costs on legal documents resulting in the establishment of a contract and for the surety and retentions.

13 Language of Contract

The contract documents will be compiled in English and the English versions of all referred documents will be taken as applicable.

14 Procurement Policy

Bids will be awarded in accordance with the Preferential Procurement Regulations, 2017 pertaining to the Preferential Procurement Policy Framework Act, No 5 of 2000.

15 Expenses Incurred in Preparation of Bid

The Garden Route District Municipality shall not be liable for any expenses incurred in the preparation and submission of the bid.

16 Wrong Information Furnished

Where a contract has been awarded on the strength of the information furnished by the bidder which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Garden Route District Municipality may, in addition to any other legal remedy it may have, recover from the contractor all costs, losses or damages incurred or sustained by the Municipality as a result of the award of the contract.

17 Validity Period

*Bids shall remain valid for **90 days** after the bid closure date.*

18 General and Special Conditions of Contract

The General Conditions of Contract as well as any Special Conditions of Contract that may form part of this set of bid documents will be applicable to this bid in addition to the conditions of bid.

19 Municipal Rates, Taxes and Charges

The bidder to provide their municipal account of rates and taxes of both the Bidding entity and its directors' in its Bid Document submission. TERMS OF REFERENCE

1. INTRODUCTION

The Garden Route District Municipality requires a service provider for the supply, delivery and off-loading of road/traffic signs.

2. DEMARCATION

Road/traffic signs to be supplied, delivered and off-loaded to the following three road depots:

- Riversdale: Vermaaklikheid Road
- George: 3 Mission Street
- Oudtshoorn: Voortrekker Road

3. SCOPE OF WORK

All road/traffic signs as per detailed specifications

Please note that each sign must be supplied with ready bolts, springnuts, washers and ready bars.

4. TENDER PERIOD

The tender period will be for a period of three years from date of award.

5. DELIVERY PERIOD

The delivery period for signs shall be 20 days maximum from the date of order.

6. PRICE

Price per item must be inclusive of bolts, nuts, washers and ready bars.

7. SABS CERTIFICATES

All relevant SABS approved certificates (as contained in the specifications) must be attached to the tender documents

TENDER SPECIFICATIONS

1. SERIES 5000: COLTO

5602 MATERIALS

(1) Structural steel

Structural steel shall comply with the requirements of BS 4360 for the type of steel specified. Unless otherwise specified, channels, square tubes, angle irons and other steel members on the reverse side of the sign boards and steel tubes for sign supports shall be coated in accordance with sub clause 5603(a).

Where specified, all structural steel, including tubes shall be galvanized in accordance with the requirements of SABS 763 for type A1 or B2 articles, as may be applicable.

Steel tubes shall comply with the requirements of SABS 657.

(2) Bolts, nuts and rivets

Steel bolts and nuts shall comply with SABS 135 or SABS 1143. Aluminium bolts and nuts shall be manufactured from alloy B51S or D65S.

All steel bolts, nuts and washers shall have a hot-dip (galvanized) zinc coating which complies with the requirements of SABS 763 for coatings on type C2 articles.

Blind rivets used for fixing road sign boards to square-tubing framework shall be 4,65 mm rivets manufactured from or coated with a material that will not cause corrosion through electrolytic action. Hardened blind or aluminum rivets shall be used for attaching aluminum sections.

(3) Steel plate and steel profiles

(i) Steel plate

Steel plate for road signs shall be 1,00 mm thick prepainted galvanized steel plate (Isacor G275 Chromadek or approved equivalent), which has been treated on both sides with an epoxy primer followed by a silicon polyester top coat. The total dry thickness of the treatment shall be at least 25 µm.

The reverse side of a STOP sign R1 and all its derivatives shall be painted white. The reverse side of all other signs shall be dark grey.

Where a reflectorized road sign is required, its reverse side shall be painted with a dull grey prime coat and the face with only the specified top coat.

(ii) Steel profiles

Standard sign profiles shall be 200 mm sections with a thickness of 1,0 mm, manufactured from prepainted galvanized mild steel substrate (Isacor G275 Chromadek or approved equivalent), and shall comply with the details on the drawings.

(4) Other plate material

Temporary roadworks delineator's signs TW401 and TW402 shall be manufactured from a flexible material and shall comply with the requirements of SABS 1555.

Aluminum plate shall be manufactured from grade 5251.H.3 alloy and shall comply with the requirements of BS 1470 and shall be 2,0 mm thickness.

(5) Paint

All paints used shall comply with the requirements of CKS 193, and also with the standards mentioned therein.

Except where reflecting surfaces are specified, the surface of painted road signs shall be semi-matt. The 60° specular gloss measured in accordance with SABS method 134 shall not exceed 50. No thinners shall be added to the paint.

The reference numbers of the colours to be used are B49 Golden Yellow, A11 Signal Red, G13 Dark Grey, F04 National Flag Blue, E08 Flag Green, B03 Dark Brown and G80 Cloud White as shown in SABS 1091.

In the case of prepainted steel plate, the contractor shall ensure that the colours and shades thereof match with those shown in SABS 1091.

(6) Retro-reflective material

Retro-reflective material shall be supplied in the following grades and shall comply with the requirements of SABS 1519 and the adhesion requirements of CKS 191:

Class I material - 7 year warranty grade
Class II material - 10 year warranty grade
Class III material - 10 year warranty grade

The material shall be supplied with a pressure sensitive or heat applied adhesive backing protected by a removable lining.

A certified copy of the Trust deed (document) as well as a letter of authority in the case of business trust.

A PARTNERSHIP

A certified copy of the Partnership Agreement.

A SOLE PROPRIETOR

A certified copy of the Owner's ID document.

In all cases, a valid Tax Clearance certificate is required.

Where necessary certified copies of other relevant registration certificates pertaining to the business as required by legislation.

The above documentation did not include necessarily all the documentation that may be needed by the Supply Chain department which must also be requested.
