BID CONDITIONS AND INFORMATION

1 Agreement

The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by the Garden Route District Municipality that his/her bid has been accepted.

2 Completion of Bid Documents

- (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
- (b) Bid documents may not be retyped or altered in any way.

3 Alteration or Qualification of Bid

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before the closure date.

4 Authorised Signatory

- (a) A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.

5 Submission of Bid

- (a) The bid must be put in a sealed envelope, or envelopes when the two-envelope system is specified, clearly marked with the bid number, title as well as closing date and time and placed in the **Tender Box** at the Garden Route District Municipality by not later than 11h00 on 14 May 2019.

- Bids received in time recorded and entered in a register which is open for public inspection.

7 Tax Clearance Certificate

a. A valid original Tax Clearance Certificate must accompany the bid documents.

<u>The onus is on the bidder to ensure that the Eden District Municipality has an original Tax Clearance</u> <u>Certificate on record</u> and obtain confirmation from the Supply Chain Management Unit of the Garden Route District Municipality.

The Garden Route District Municipality reserves the right not to award proposals to prospective suppliers who are not registered on the CSD (Central Supplier Database).

11 Site / Information Meetings

12 Stamp and Other Duties

The successful bidder will be liable for all duties and costs on legal documents resulting in the establishment of a contract and for the surety and retentions.

13 Language of Contract

The contract documents will be compiled in English and the English versions of all referred documents will be taken as applicable.

14 Procurement Policy

Bids will be awarded in accordance with the Preferential Procurement Regulations, 2001 pertaining to the Preferential Procurement Policy Framework Act, No 5 of 2000.

15 Expenses Incurred in Preparation of Bid

16 Wrong Information Furnished

Where a contract has been awarded on the strength of the information furnished by the bidder which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Garden Route District Municipality may, in addition to any other legal remedy it may have, recover from the contractor all costs, losses or damages incurred or sustained by the Municipality as a result of the award of the contract.

17 Validity Period

Bids shall remain valid for 90 days after the bid closure date.

18 General and Special Conditions of Contract

The General Conditions of Contract as well as any Special Conditions of Contract that may form part of this set of bid documents will be applicable to this bid in addition to the conditions of bid.

19 Municipal Rates, Taxes and Charges

GARDEN ROUTE DISTRICT MUNICIPALITY TERMS OF REFERENCE

1. INTRODUCTION

The Garden Route District Municipality hereby invites prospective service providers to tender for the supply, delivery and fitting of two (2) aluminium service canopies.

2. DEFINITION

Aluminium lockable service canopies are required to safeguard equipment on the back of LDV's (Light Delivery Van: Ford Ranger S/C 2.2 Diesel, 2014 and Nissan NP300 2.5 Diesel, 2012. The service canopies make provision for the storing of tools and equipment while working outside of the mechanical workshop. Canopies must be manufactured of aluminium as set out in the specifications with a high quality finish.

3. DEMARCATION

The service canopies required must be supplied, delivered and fitted at the Mechanical Workshop, Roads Services Department, Mission Road, George for the Ford Ranger and the Mechanical Workshop, Roads Department, Voortrekker Road, Oudtshoorn for the Nissan.

4. SCOPE OF WORK

Supply, delivery and fitting of two (2) aluminium canopies as per tender specifications.

SPECIFICATIONS

(Local content)

- 1. Completely manufactured from aluminium.
- 2. Frame to be constructed from aluminium square tubing (25mm x 25mm x 3mm) which includes two inner departments with flip-up lids for storage.
- 3. The front lids must be constructed from 3mm aluminium and spray painted white.
- 4. The balance of the canopy cladding is done with 1.5mm aluminium tread (patterned) plate.
- 5. The canopy must be designed to fit on the cab side half of the load bin and must be the height of the cab of the vehicle.
- 6. A rear, removable, lid with lockable T-handle must be fitted on the remainder of the load bin. The lid must be manufactured from aluminium tread plate with a reinforced tubular frame (50mm x 25mm x 3mm).
- 7. Supply and installation of an Amber LED strobe light (STRIP) for each canopy.
- 8. All lids to be sealed against dust and water.
- 9. Back lid to be installed with 2 x 8 mm Gas stay struts with max force 100 kg (extended length 800mm; close length 418mm.


