1 Agreement

The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by the Garden Route District Municipality that his/her bid has been accepted.

2 Completion of Bid Documents

- (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
- (b) Bid documents may not be retyped or altered in any way.

3 Alteration or Qualification of Bid

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before the closure date.

4 Authorised Signatory

- (a) A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.

5 Submission of Bid

- (a) The bid must be put in a sealed envelope, or envelopes when the two-envelope system is specified, clearly marked with the bid number, title as well as closing date and time and placed in the **Tender Box at the Garden Route District Municipality by not later than 11h00 on 07 June 2019.**
- (b) Faxed, e-mailed and late bids will not be accepted. Bids may be delivered by hand, by courier, or posted at the bidder's risk and must be received by the deadline specified above, irrespective of how they are sent or delivered.

6 Opening, Recording and Publications of Bids Received.

- Bids will be opened in public immediately after the bid closure date, or at such
- time as specified in the bid documents. If requested by any bidder present,
- names of the bidders, and if practical the total amount of each bid and of any alternative bids will be read out loud.
- Bids received in time recorded and entered in a register which is open for public inspection.

7 Tax Clearance Certificate

- a. A valid original Tax Clearance Certificate must accompany the bid documents. The onus is on the bidder to ensure that the Garden Route District Municipality has an original Tax Clearance Certificate on record and obtain confirmation from the Supply Chain Management Unit of the Garden Route District Municipality.

The Garden Route District Municipality reserves the right not to award proposals to prospective suppliers who are not registered on the CSD (Central Supplier Database).

Bids will be awarded in accordance with the Preferential Procurement Regulations, 2017 pertaining to the Preferential Procurement Policy Framework Act, No 5 of 2000.

- 16 Wrong Information Furnished**
Where a contract has been awarded on the strength of the information furnished by the bidder which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Garden Route District Municipality may, in addition to any other legal remedy it may have, recover from the contractor all costs, losses or damages incurred or sustained by the Municipality as a result of the award of the contract.
- 17 Validity Period**
Bids shall remain valid for 90 days after the bid closure date.
- 18 General and Special Conditions of Contract**
The General Conditions of Contract as well as any Special Conditions of Contract that may form part of this set of bid documents will be applicable to this bid in addition to the conditions of bid.

TERMS OF REFERENCE

Tenders are hereby invited for the supply and delivery of gabion boxes and mattresses for a period of 3 years.

1. THE FOLLOWING REQUIREMENTS MUST BE MET:

- 1.1 All products tendered for must meet the applicable South African National Standards (SANS) specifications. **Proof of SANS certificate must be attached to the tender document.**
- 1.2 Tender prices must include delivery costs, where applicable. Collection and delivery is applicable to relevant Road Depots in George, Oudtshoorn and Riversdale.

2. MANUFACTURER'S SPECIFICATIONS

- 2.1 The specifications stated in this tender document are the minimum requirements.

3. DELIVERY PERIOD

- 3.1 Delivery may not exceed ten (10) working days.

4. SPECIAL CONDITIONS

- 4.1 (Local content)
- 4.2 Service providers must give an indication whether a part of this tender will be sub-contracted to a subsidiary or sister company. If such, only one of the entities will be allowed to tender.
- 4.3 Service providers must provide proof of his business location (municipal account), which can be inspected at any time during the term of this contract by an official of the Garden Route District Municipality.
- 4.4 This contract is covered under the General Conditions of Contract as contained in the tender document.
- 4.5 The service provider shall not be entitled to cede or assign any of its rights or delegate any of its obligations or duties, nor any part thereof acquired without the written consent of the district municipality.

SPECIFICATIONS

(In accordance with SABS 1580:1993 except for mesh dimensions, diameter of wire and PCV coating)

(Local content)

1. GENERAL

Gabion cages shall be fabricated from wire mesh of the size and type and selvedge as specified hereinafter. The cages shall be subdivided into cells by wire mesh diaphragms and shall be of two types:

1.1 Boxes which are generally used for the construction of gabion walls, functioning as a bulkhead (e.g. toe protection in combination with revetment types of protection), groyne, baffle or similar protective device. Boxes shall be subdivided into cells by diaphragms spaced at 1,0 m intervals. Sizes required under this contract are as follows:-

- 80 mm x 100 mm MESH, 2,7 mm wire, core size 2 m x 1 m x 1 m with necessary binding wire
- 80 mm x 100 mm MESH, 2,7 mm wire, core size 2 m x 1 m x 0,5 m with necessary binding wire
- 80 mm x 100 mm MESH, 2,7 mm wire, core size 1 m x 1 m x 1 m with necessary binding wire

1.2 Mattresses which are generally used as armour to artificially surface bed, banks or embankment to resist erosion or scour. The base, sides and two ends shall be made of a single sheet (mainsheet) of wire mesh whereas the lid may be formed separately from single sheet. Partition panels, made of the same type of wire mesh, shall be attached to the base of the main sheet to form 1,000 m pockets into which the mattress is divided.

- 80 mm x 100 mm MESH, 2,7 mm wire, core size 6 m x 2 m x 0,3 m with necessary binding wire

In addition, top lid sections only, complete with selvedge will be required as specified in the schedule of quantities.

- 80 mm x 100 mm MESH, 2,7 mm wire. (Selvedged equal or greater than 3,4mm). Including binding wire along the selvedges

2. COLOURS

Grey and Brown

3. WIRE MESH

Wire mesh shall be hexagonal-woven mesh wherein the joints are formed by twisting each pair of wire through three half turns.

The tightness of the twisted joints shall be such that a force of not less than 1,7 kN is required when pulling on one wire in order to separate it from the other wire provided each wire is prevented from turning and the applied forces and the wire are all kept in the same place. The size of the mesh shall be 80 mm x 100 mm.

The shorter dimensions of the mesh shall be taken from centre to centre of the twisted joints and the larger dimensions shall be between the inside ends of twisted joints.

4. WIRE

All wire used in the fabrication of the gabions and in the wiring operations during construction shall be to SANS 1580, having a tensile strength of not less than 350 Mpa (SANS 675).

The diameter of the wire used in the fabrication of the netting shall be: 2,7 mm (SANS 1580:2005) for PVC coated units.

5. PROTECTION

5.1 Galvanizing

All wire used in the fabrication of gabions shall be coated with a zinc aluminum alloy containing 5% aluminum (SANS 1580).

The adhesion of the zinc alloy coating to the wire shall be such that when the wire is wrapped six turns round a mandrel of four times the diameter of the wire, it shall not flake nor crack to such an extent that any zinc alloy can be removed by rubbing with the bare fingers.

5.2 PVC

After galvanizing, the wire shall, as indicated in the specifications, have extruded on to it a coating of poly vinyl chloride, otherwise referred to as PVC.

The coating shall be grey or brown in colour, shall nowhere be less than 0,50 mm in thickness and shall have the following properties:-

5.2.1 Hardness

48,5 SHORE D units in accordance with ASTM 1706.

5.2.2 Tensile Strength

23 Mpa in accordance with ASTM/D412.

5.2.3 Elongation

291 % in accordance with ASTM/D412.

5.2.4 Modulus of Elasticity

At 100% elongation: 20 Mpa in accordance with ASTM/D412.

5.2.5 Brittleness Temperature

The temperature reached in the test, Method 151A BSS 2782/1974 should not be higher than - 35°C.

5.2.6 Bonding to wire core

After immersion of a length of the coated wire in a 1% solution of Potassium Permanganate for a continuous period of 2 000 hours at an ambient temperature, the maximum penetration between the coating and the wire core from a square cut end shall be 25 mm.

5.2.7 Resistance to corrosion of the PVC

After immersion of a length of coated wire excluding the ends in a concentrated solution of sodium chloride for a continuous period of 60 hours at an ambient temperature, there shall be no loss of mass.

5.2.8 Resistance to creeping corrosion

After immersion of a length of the coated wire in a 50 % solution of Hydrochloric acid for a continuous period of 2 000 hours at an ambient temperature, between 5°C and 30°C, the maximum penetration of corrosion of the wire core from a square cut end shall be 25 mm.

5.2.9 Resistance to abrasion

When subjected to tests in accordance with DIN 53516 the resistance must be at least 50% greater than that given by the specified DIN 53516 control materials; vulcanized rubber compound.

5.2.10 Ageing and Resistance to Ultra-violet light

After exposure to Ultra-violet light and to ageing WEATHEROMETER TYPE XW test in accordance with ASTM G23 for a continuous period of 3 000 hours the PVC shall not show any material difference in the above properties except in the undermentioned wherein a tolerance of $\pm 10\%$ is allowable:-

(i) Hardness

59,5 SHORE D units in accordance with ASTM 1706.

(ii) Tensile Strength

23 Mpa in accordance with ASTM D412.

(iii) Modulus of Elasticity

At 100% elongation. 23 Mpa in accordance with ADTM D412.

5.2.11 Resistance to High Temperature

After exposure at 100°C for a continuous period of 100 hours the PVC shall not show any material difference in the above properties except in the undermentioned wherein a tolerance of $\pm 10\%$ is allowable:-

(i) Hardness

49,0 SHORE D units in accordance with ASTM 1706.

(ii) Tensile Strength

23 Mpa in accordance with ASTM D412.

(iii) Modulus of Elasticity

At 100% elongation 21 Mpa in accordance with ASTM D412.

6. SELF-EDGES

All the edges of the cages, diaphragms and end panels, except as stated in clause 6, shall be self-edged.

The wire used for the self-edged shall have a diameter greater than that of the wire used to form the mesh, namely:

- (i) For the mesh made of wire having a diameter of 2,7mm, the selvedge shall be of the wire having a diameter equal to or greater than 3,4 mm.
- (ii) Where the self-edge is not woven integrally with the mesh but has to be fastened to the cut ends of the mesh, it must be attached by binding the cut ends of the mesh, about it so that a force of not less than 8,5 kN applied in the same plane as the mesh, at a point on the selvedge of a mesh sample 1 m long, is required to separate it from the mesh.

7. DIAPHRAGMS AND END-PANELS

The diaphragms and end-panels shall be self-edged on the top and vertical sides only.

For box gabions the end-panels shall be attached by twisting the cut ends of the mesh wires at the bottom of the gabions. Similarly, the diaphragms shall be attached by twisting the cut ends of the mesh to the twisted joints of the mesh of the base of the box gabion.

Mattresses shall be constructed with the end panels formed as specified in clause 1.2; whilst the diaphragms shall be attached with a helical wire connecting each diaphragms to the bottom of the mattress. This helical wire shall be of sufficient length to facilitate securing of the vertical sides of the diaphragms to the side panels.

In each case the force required to separate the panels from the base should not be less than that required to break the mesh over the same length.

8. BINDING WIRE

Sufficient binding and connecting wire must be supplied with the gabions and mattresses for all the wiring operations to be carried out in the construction of the cages and to be provide the required inter-connection of all units in a structure according to a standard method. The standard method of securing the binding wire shall be as follows:-

Begin wiring up to securing the binding wire at the top corners of the panels to be joined by looping it through and twisting it together. Then lace the wire around the self edges with single loops and double loops in turn at 100 mm intervals. Finally, fasten the wire securely at the bottom corner, and poke the loose ends inside the cage.

The cages shall be wired together using the exact same method as for assembling single cages as hereinbefore described.

The diameter of binding wire shall be:-

- (i) 2,2 mm for the cages made of wire gauge 2,7 mm.
- (ii) 2,2 mm for the mattresses made of wire gauge 2,7 mm.

Tenderers shall also submit pamphlets illustrating their recommended binding and connecting systems, on which they have based their binding and connecting wire quantities.

General Conditions of Contract

1. Definitions

1. The following terms shall be interpreted as indicated:
 - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2 "Contract" means the written agreement entered into between the purchaser and the provider, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3 "Contract price" means the price payable to the provider under the contract for the full and proper performance of his contractual obligations.
 - 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
 - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
 - 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
 - 1.7 "Day" means calendar day.
 - 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
 - 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
 - 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the provider bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
 - 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
 - 1.12 "Force majeure" means an event beyond the control of the provider and not involving the provider's fault or negligence and not foreseeable.
