- 1 **Agreement**
The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by the Garden Route District Municipality that his/her bid has been accepted.
- 2 **Completion of Bid Documents**
 - (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
 - (b) Bid documents may not be retyped or altered in any way.
- 3 **Alteration or Qualification of Bid**
No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before the closure date.
- 4 **Authorised Signatory**
 - (a) A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.
 - (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.
- 5 **Submission of Bid**
 - (a) The bid must be put in a sealed envelope, or envelopes when the two-envelope system is specified, clearly marked with the bid number, title as well as closing date and time and placed in the **Tender Box at the Garden Route District Municipality by not later than 11h00 on 08 August 2019.**

17 Validity Period

Bids shall remain valid for 90 days after the bid closure date.

18 General and Special Conditions of Contract

The General Conditions of Contract as well as any Special Conditions of Contract that may form part of this set of bid documents will be applicable to this bid in addition to the conditions of bid.

1. GENERAL INTRODUCTION AND BACKGROUND

Development Agencies are particularly suited to the achievement of the objectives of socio-economic development and growth in the post democracy South Africa context, insofar as they allow for the provision of infrastructure, economic growth and security for investments in the region and the country at large. Additionally, when undertaken in the framework of implementing projects in Public-Private Partnerships, they could enlist the financial and managerial capabilities of the private sector in widening the scope of productive activity in the region.

Development Agency are created under widely different circumstances and with different policy intentions. What is common to all efforts is the provision of land, infrastructure and investor/business support services that could facilitate one or more of the following:

- Establishment/expansion of value chains by clustering similar or linked industries;
- Stimulation and absorption of new technologies through technology parks;
- Incubation of new businesses (SMEs, Start-ups);
- Catalyzing economic activity in specific locations;
- Provision of stable infrastructure and competitively priced land and services for businesses;
- Stimulation of export industry, bonded warehouses and efficient trading and transport infrastructure and trade related services;
- Assurance of security for business investments and assets;
- Concentrating the location of industries for improved municipal zoning, urban planning and/or environmental impact management.
- Thinking Regionally in every respect

The concept of “Development Agencies”, is not new to the South African experience. The state and other state institutions utilized the Development Agencies approach for the development of particular sectors. Despite the familiarity with the concept, as in other aspects of the South African economy, there is a need to move away from the state and public sector led approach to more modern, private sector business oriented models for the development and management socio-economic aspects of the region.

It is against this background that the GRDM wishes to request proposal from suitably qualified specialist to carry out the work outlined in this call.

2. FEASIBILITY STUDY AND BUSINESS PLAN DEVELOPMENT FOR THE ESTABLISHMENT OF A DISTRICT DEVELOPMENT AGENCY

The activities and outputs covered by the present Terms of Reference will provide the concerned decision makers in GRDM, a basis for assessing:

- Policy options to the design of the Development Agency;
- Investments required in the establishment of Development Agency;
- Different roles that could be played by the GRDM and other stakeholders in establishing and managing the Agency;
- Financial feasibility of the business model of the Agency;
- Financial options for the implementation of the Agency.

This will be notably achieved by conducting a feasibility study for the proposed idea in GRDM. The study will be undertaken for the region and is envisaged, to examine the viability of a development agency and possible models for developing, financing and managing such an entity. Therefore the feasibility study will be a more conventional exercise, dealing with the financial viability and contribution to the strategic objective of GRDM. The studies and assessments completed under the contract will be synthesised into key findings and recommendations that will:

- i) facilitate investment decisions for the Agency in the district
- ii) be incorporated into a Road Map for the establishment of a Development Agency in Garden Route Region.

The GRDM, therefore, invites suitably qualified services providers to respond to this Request to submit proposal for the provision of the outlined services in line with the terms of reference contained in this request for proposals.

The successful respondents should have the capacity and expertise to meet the requirements of GRDM in as far as these services are concerned.

3. OBJECTIVES AND SCOPE OF WORK

The objectives of the assignment which is to conduct a feasibility study and development of operational business plan with a view to establish a Development Agency for the district that will assist performing the mandate as outlined in the constitution.

Key activities in undertaking the work shall include:

- a) The terms of reference for the feasibility study include the following:
- Evaluate the (external) environment within which the Agency will function.
 - Evaluate the current situation of the project in question. This will include an analysis of the situation and possible legal and regulatory requirements.
 - Determine the requirements for the successful initiation and management of the Agency i.e. finance, organisation, skills, public sector inputs, infrastructure, support services and other requirements.
 - Determine possible barriers to the proposal (including the socio-cultural factors).
 - Provide a financial analysis.
 - Provide recommendations
- b) The terms of reference for the business plans should include:
- Information on the local economic development space
 - Products or services, immediate and potential
 - Market research and analysis
 - Design and development plans
 - Critical risks, problems, and assumptions and the means to mitigate them
 - The financial plan including conditions for entity viability and sustainability
 - An ownership and management structure.

4. THE DEVELOPMENT AGENCY ESTABLISHMENT

The GRDM has embarked on the process to establish an independent development body (Development Agency) to drive economic development throughout the region. The establishment of an Agency was identified as a suitable mechanism to ensure that high level projects are successfully implemented in light of the financial and human resource capacity constraints of the various local authorities .The Agency is not going to replace the LED Units in the district. The LED will also play its role on the formulation of policies among other roles and the Agency will implement those.

5. FINALISATION OF SCOPE OF WORK AND PROJECT MANAGEMENT

The final scope of work will be formalised in a Project Implementation and Management Plan, which will be an outcome of the first meeting between the project steering committee and the service provider.

6. PROPOSED APPROACH, BUDGET AND PROGRAMME

General Conditions of Contract

1. Definitions

1. The following terms shall be interpreted as indicated:
 - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2 "Contract" means the written agreement entered into between the purchaser and the provider, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3 "Contract price" means the price payable to the provider under the contract for the full and proper performance of his contractual obligations.
 - 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
 - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
 - 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
 - 1.7 "Day" means calendar day.
 - 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
 - 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
 - 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the provider bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
 - 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
 - 1.12 "Force majeure" means an event beyond the control of the provider and not involving the provider's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
 - 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
 - 1.14 "GCC" means the General Conditions of Contract.
 - 1.15 "Goods" means all of the equipment, machinery, and/or other materials that the provider is required to supply to the purchaser under the contract.
 - 1.16 "Imported content" means that portion of the bidding price represented by the cost of components, parts or materials which have been or are still to be imported (whether by the provider or his subcontractors) and which costs are inclusive of the costs abroad, plus freight and other direct importation costs such as landing costs, dock dues, import duty, sales duty or other similar tax or duty at the South African place of entry as well as transportation and handling charges to the factory in the Republic where the supplies covered by the bid will be manufactured.
 - 1.17 "Local content" means that portion of the bidding price which is not included in the imported content provided that local manufacture does take place.
 - 1.18 "Manufacture" means the production of products in a factory using labour, materials, components and machinery and includes other related value-adding activities.
 - 1.19 "Order" means an official written order issued for the supply of goods or works or the rendering of a service.

The provider further warrants that all goods supplied under this contract shall have no defect, arising from design, materials, or workmanship (except when the design and/or material is required by the purchaser's specifications) or from any act or omission of the provider, that may develop under normal use of the supplied goods in the conditions prevailing in the country of final destination.</p> <p>15.2 This warranty shall remain valid for twelve (12) months after the goods, or any portion thereof as the case may be, have been delivered to and accepted at the final destination indicated in the contract, or for eighteen (18) months after the date of shipment from the port or place of loading in the source country, whichever period concludes earlier, unless specified otherwise.</p> <p>15.3 The purchaser shall promptly notify the provider in writing of any claims arising under this warranty.</p> <p>15.4 Upon receipt of such notice, the provider shall, within the period specified and with all reasonable speed, repair or replace the defective goods or parts thereof, without costs to the purchaser.</p> <p>15.5 If the provider, having been notified, fails to remedy the defect(s) within the period specified, the purchaser may proceed to take such remedial action as may be necessary, at the provider's risk and expense and without prejudice to any other rights which the purchaser may have against the provider under the contract.</p>

Payment	<p>16.1 The method and conditions of payment to be made to the provider under this contract shall be specified.</p> <p>16.2 The provider shall furnish the purchaser with an invoice accompanied by a copy of the delivery note and upon fulfilment of other obligations stipulated in the contract.</p> <p>16.3 Payments shall be made promptly by the purchaser, but in no case later than thirty (30) days after submission of an invoice or claim by the provider.</p> <p>16.4 Payment will be made in Rand unless otherwise stipulated.</p>
