#### **BID CONDITIONS AND INFORMATION**

#### 1 Agreement

The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by the Garden Route District Municipality that his/her bid has been accepted.

## 2 Completion of Bid Documents

- (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
- (b) Bid documents may not be retyped or altered in any way.

#### 3 Alteration or Qualification of Bid

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before the closure date.

## 4 Authorised Signatory

- (a) A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.

#### 5 Submission of Bid

- (a) The bid must be put in a sealed envelope, or envelopes when the two-envelope system is specified, clearly marked with the bid number, title as well as closing date and time and placed in the Tender Box at the Garden Route District Municipality by not later than 11h00 on 11 July 2019
- (b) Faxed, e-mailed and late bids will not be accepted. Bids may be delivered by hand, by courier, or posted at the bidder's risk and must be received by the deadline specified above, irrespective of how they are sent or delivered.

## 6 Opening, Recording and Publications of Bids Received.

- Bids will be opened in public immediately after the bid closure date, or at such
- time as specified in the bid documents. If requested by any bidder present,
- names of the bidders, and if practical the total amount of each bid and of any alternative bids will be read out loud.
- Bids received in time recorded and entered in a register which is open for public inspection.

#### 7 Tax Clearance Certificate

- A valid original Tax Clearance Certificate must accompany the bid documents.
   The onus is on the bidder to ensure that the Garden Route District Municipality has an original Tax Clearance
   Certificate on record and obtain confirmation from the Supply Chain Management Unit of the Garden Route
   District Municipality.
- b. Bids not supported by a valid original Tax Clearance Certificate, as an attachment to the bid documents will be invalidated.
- c. In bids where consortia/joint ventures/sub-contractors are involved, each party must submit a separate valid original Tax Clearance Certificate.

# 8 Evaluation of Bids

Bids will be evaluated in terms of their responsiveness to the bid specifications and requirements as well as such additional criteria as set out in the bid documents.

## 9 Acceptance or Rejection of a Bids

The Garden Route District Municipality reserves the right to withdraw any invitation to submit a bid and/or to re-advertise or to reject any bid or to accept a part of it. The Garden Route District Municipality does not bind itself to accepting the lowest bid.

#### 10 Registration on Accredited Supplier Database

It is expected of all prospective service providers who are not yet registered on the Central Supplier Database to register online (<a href="www.csd.gov.za">www.csd.gov.za</a>) and verify their company information at Garden Route District Municipality Database Department. The Garden Route District Municipality reserves the right not to award proposals to prospective suppliers who are not registered on the CSD (Central Supplier Database).

#### 12 Stamp and Other Duties

The successful bidder will be liable for all duties and costs on legal documents resulting in the establishment of a contract and for the surety and retentions.

#### 13 Language of Contract

The contract documents will be compiled in English and the English versions of all referred documents will be taken as applicable.

## 14 Procurement Policy

Bids will be awarded in accordance with the Preferential Procurement Regulations, 2017 pertaining to the Preferential Procurement Policy Framework Act, No 5 of 2000.

#### 15 Expenses Incurred in Preparation of Bid

The Garden Route District Municipality shall not be liable for any expenses incurred in the preparation and submission of the bid.

#### 16 Wrong Information Furnished

Where a contract has been awarded on the strength of the information furnished by the bidder which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Garden Route District Municipality may, in addition to any other legal remedy it may have, recover from the contractor all costs, losses or damages incurred or sustained by the Municipality as a result of the award of the contract.

#### 17 Validity Period

Bids shall remain valid for 90 days after the bid closure date.

## 18 General and Special Conditions of Contract

The General Conditions of Contract as well as any Special Conditions of Contract that may form part of this set of bid documents will be applicable to this bid in addition to the conditions of bid.

#### 19 Municipal Rates, Taxes and Charges

The bidder to provide their municipal account of rates and taxes of both the Bidding entity and its directors' in its Bid Document submission. Any bidder which is or whose directors are in arrear with their municipal rates and taxes due to any Municipality within South Africa for more than three months and have not made an arrangement for settlement of or same before the bid closure date will be disqualified.

#### **TERMS OF REFERENCE**

# **SPECIFICATIONS: Oudtshoorn Construction site's**

Security is required for Constructions sites (25km radius) around Oudtshoorn. Security will only involve the safekeeping of construction vehicles during after-hours.

# 1. STAFF

1 x Security Officer (working in shifts)

# 2. PERIOD

- Security services will be rendered every working day from 16h00 until 08h00 the next day. Weekends and public holidays will be 24 hours. On Fridays the shift must start at 13h00.
- > 15 July 2019 to 30 Aug 2019

# 3. REQUIREMENTS

## 3.1 BIDDERS REGISTRATION

- The bidder must be registered with the Private Security Industries Regulatory Authority (PSIRA).
- A certified copy of the registration document should be included in tender documents.
- > Bidders who are not registered with PSIRA bids will be non-responsive.
- Proof of registration at the Department of Labour must be attached to the tender documents.

# 3.2 SECURITY OFFICERS

- The bidders must ensure that all security officers are qualified to a level minimum grade D.
- All security officers must be registered with PSIRA and proof of registration must be made available.
- ➤ All security officers must be able to communicate in two of the official languages in terms of the Municipality's language policy (Afrikaans, English and/or Xhosa).

# 3.3 PUBLIC LIABILITY INSURANCE

➤ Proof that the Bidder has Public Liability Insurance of at least R1 000 000 should accompany the tender documents.

## 3.4 REPLACEMENT GUARD

- The successful bidder will be responsible for a replacement in the event of a security guard not reporting for duty and for full payment thereof.
- A back up guard should be available at all times in case of an emergency.
- If the bidder is unable to find a replacement, the district municipality will find such a

replacement, for the account of the successful bidder.

# 4. GENERAL REQUIREMENTS

- Except where otherwise specified, the bidder shall provide all labour, transport, stationary, uniforms (rain coats, umbrella's), radio communications and any other equipment (torch, nightstick) for the rendering of the service included in the specifications.
- The security guard on duty must be in contact via radio/cellular phone with the company's control centre for reporting and emergencies.
- The security guard on duty must patrol the entire site where vehicles is parked and report every hour to the company's control centre. All incidents must be reported to the Eden District Municipality's Disaster Management Centre at tel <u>044 803 1314.</u>
- ➤ Hourly entries must be done in the incident register. The incident register must be provided by the security company.

# 5. RULES REGARDING ACCESS TO THE PREMISES IN MISSION ROAD, GEORGE

- ➤ The Security Officer <u>MUST</u> complete the visitors register for any person entering the site. Drivers will be expected to provide the following information on visits:
  - Reason for visit
  - ♣ Type of items/articles delivered/collected, if any
- All problems regarding the security services, as observed or experienced, must immediately be written in the incident register at the security office at the main entrance. With the first follow-up visit at Eden DM premises the supervisor of the security company is expected to visit the responsible officer in order to resolve any problems.



#### **General Conditions of Contract**

#### 1. Definitions

- 1. The following terms shall be interpreted as indicated:
- 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2 "Contract" means the written agreement entered into between the purchaser and the provider, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3 "Contract price" means the price payable to the provider under the contract for the full and proper performance of his contractual obligations.
- 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7 "Day" means calendar day.
- 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
- 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
- 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the provider bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
