## BID CONDITIONS AND INFORMATION

### 1 Agreement

The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by the Garden Route District Municipality that his/her bid has been accepted.

### 2 Completion of Bid Documents

- (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
- (b) Bid documents may not be retyped or altered in any way.

### 3 Alteration or Qualification of Bid

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before the closure date.

### 4 Authorised Signatory

- (a) A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.

### 5 Submission of Bid

- (a) The bid must be put in a sealed envelope, or envelopes when the two-envelope system is specified, clearly marked with the bid number, title as well as closing date and time and placed in the **Tender Box at the Garden Route District Municipality by not later than 11h00 on 21 August 2019.**
- (b) Faxed, e-mailed and late bids will not be accepted. Bids may be delivered by hand, by courier, or posted at the bidder's risk and must be received by the deadline specified above, irrespective of how they are sent or delivered.

### 6 Opening, Recording and Publications of Bids Received.

- Bids will be opened in public immediately after the bid closure date, or at such
- time as specified in the bid documents. If requested by any bidder present,
- names of the bidders, and if practical the total amount of each bid and of any alternative bids will be read out loud.
- Bids received in time recorded and entered in a register which is open for public inspection.

### 7 Tax Clearance Certificate

- a. A valid original Tax Clearance Certificate must accompany the bid documents. The onus is on the bidder to ensure that the Garden Route District Municipality has an original Tax Clearance Certificate on record and obtain confirmation from the Supply Chain Management Unit of the Garden Route District Municipality.
- b. Bids not supported by a valid original Tax Clearance Certificate, as an attachment to the bid documents will be invalidated.
- c. In bids where consortia/joint ventures/sub-contractors are involved, each party must submit a separate valid original Tax Clearance Certificate.

### 8 Evaluation of Bids

Bids will be evaluated in terms of their responsiveness to the bid specifications and requirements as well as such additional criteria as set out in the bid documents.

### 9 Acceptance or Rejection of a Bids

The Garden Route District Municipality reserves the right to withdraw any invitation to submit a bid and/or to re-advertise or to reject any bid or to accept a part of it. The Garden Route District Municipality does not bind itself to accepting the lowest bid.

### 10 Registration on Accredited Supplier Database

It is expected of all prospective service providers who are not yet registered on the Central Supplier Database to register online ([www.csd.gov.za](http://www.csd.gov.za)) and verify their company information at Garden Route District Municipality Database Department. The Garden Route District Municipality reserves the right not to award proposals to prospective suppliers who are not registered on the CSD (Central Supplier Database).

**16 Wrong Information Furnished**

Where a contract has been awarded on the strength of the information furnished by the bidder which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Garden Route District Municipality may, in addition to any other legal remedy it may have, recover from the contractor all costs, losses or damages incurred or sustained by the Municipality as a result of the award of the contract.

**1. INTRODUCTION**

- 1.1. The Garden Route District Municipality: Department Roads and Transport Planning (GRDM) intends to develop and implement an Invasive Species Monitoring, Control and Eradication Plan (hereafter referred to as the management plan). The development and implementation of the management plan forms part of the GRDM's endeavours to continuously and actively manage alien invasive plant species within the road reserve and to ensure environmental conformance and compliance.

**2. Proposal Document**

- 2.1. A comprehensive and executable proposal / project plan which demonstrates the tenderer's understanding of terms of reference must be provided. As a minimum the aforesaid must illustrate / convey the tenderers understanding of the scope of work and desired outcomes and ability to translate scope of work into clear project plan.

**3. BACKGROUND**

**Legislative Requirements**

- 3.1. In terms of the National Environmental Management: Biodiversity Act 10 of 2004 (NEMBA) and the Regulations (Alien and Invasive Species Regulations, 2014) thereunder Management Authorities of all Protected Areas and of Organs of State are required to take onus of and actively manage alien invasive species which are found within their area of jurisdiction. Furthermore Section 76 of the NEMBA calls for all Protected Area Management Authorities and all other "Organs of State in all spheres of government", including all municipalities to draw up an "Invasive Species Monitoring, Control and Eradication Plan for land under their control,". The aforesaid plan must encompass all Listed Invasive Species in terms of Section 70(1) of the NEMBA.

**Pre-Directive Notice**

- 3.2. A Notice of Intention to issue a Pre-Directive in terms of Section 73(3) of the NEMBA in respect of failure to comply with the provisions of the law in respect of the activities conducted at Garden Route District Road Reserve, Wilderness Western Cape was issued by the Department of Environmental Affairs: Enforcement. Although the principle objective of the tender is to generate a management plan which encompasses the entire district, the first point of call will be for the successful tenderer to compile a report in response to the directive which conforms to the instructions which are specified in Section 8 of the aforesaid directive.

**4. COMPETENT AUTHORITY ENGAGEMENT**

- 4.1. The successful tenderer will be required to ensure that the GRDM form part of all engagements with the Competent Authority as part of endeavours to foster cooperative governances.

**5. CONSOLIDATE**

- 5.1. Taking the above-mentioned aspects into account the resultant Invasive Species Monitoring, Control and Eradication Plan must therefore address and provide a working document which addresses the requirements laid down in:
- the Pre-Directive issued by the Department of Environmental Affairs;
  - Section 76 of the NEMBA for species listed as invasive in terms of Section 70 of the Act;
  - all applicable guidelines which are recognised by the Competent Authority, including but not limited to the "Monitoring, Control & Eradication Plans Guidelines For Species Listed as Invasive in terms of Section 70 of National Environmental Management: Biodiversity Act, 2004 (Act No. 10 of 2004) (NEMBA) and as required by Section 76 of this act" (Department of Environmental Affairs, 2015); and
  - existing methods employed by the GRDM to actively manage alien invasive species in the road reserve.
- 5.2. The successful tenderer will be required to complete the project within a timeframe of three (3) months following formal appointed by the GRDM.

**6. PRIORITY AREAS**

- 6.1. Owing to the extent of the road network which fall within the mandate of the GRDM the successful tenderer will be expected to provide a feasible method of managing alien invasive species in order of importance based on the species found within the road reserve, by means of (but not limited to) identifying and mapping priority areas.
- 6.2. The document (i.e. management plan) must be structured and as a minimum to include the following:



- Executive Summary;
- Introduction;
- Maps of the Management Unit Compartments in land under the control of the GRDM;

6.3. Furthermore, the management plan must also include the following:

- Mapping the parcels of land under the control of the GRDM Roads and Transport Planning, in management unit compartments;
- Compiling a List of Invasive Species for each management unit compartment
- Describing the prioritisation of the land parcels in the management unit compartments;
- Assessing the extent of infestations;
- Metadata must be provided;
- Report on the efficacy of previous control or eradication measures
- Recommend appropriate and feasible measures to monitor, control or eradicate Listed Invasive Species;
- Developing measurable indicators of progress and success, and indications of when the Control Plan is to be completed;
- Include an annual complete operational, equipment and human resource costing analysis (including human resource training costing);
- Include additional annual costing of invasive vegetation clearing;
- Include components such as the financials and methods aspects;
- The Monitoring and Maintenance component of the plan must set out realistic monitoring and maintenance goals, outcomes and timeframes which also addresses the following:
  - The assessment and evaluation of the impact on the receiving environment;
  - The identification of proposed remedial and mitigation measures;
  - Cost implications for undergoing remedial and mitigation measures with possible cost-effective alternatives; and
  - Must be aligned with all relevant legislative requirements.

## 7. **TENDER FUNCTIONALITY**

7.1. The bids will be pre-evaluated based on the functionality criteria provided in Table 1. **General Conditions of Contract**

**1. Definitions**

1. The following terms shall be interpreted as indicated:
  - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
  - 1.2 "Contract" means the written agreement entered into between the purchaser and the provider, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.

  - 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the provider bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.

A certified copy of the Trust deed (document) as well as a letter of authority in the case of business trust.

### **A PARTNERSHIP**

A certified copy of the Partnership Agreement.

### **A SOLE PROPRIETOR**

A certified copy of the Owner's ID document.

In all cases, a valid Tax Clearance certificate is required.

Where necessary certified copies of other relevant registration certificates pertaining to the business as required by legislation.

The above documentation did not include necessarily all the documentation that may be needed by the Supply Chain department which must also be requested.
