BID CONDITIONS AND INFORMATION

1 Agreement

The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by the Garden Route District Municipality that his/her bid has been accepted.

2 Completion of Bid Documents

- (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
- (b) Bid documents may not be retyped or altered in any way.

3 Alteration or Qualification of Bid

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before the closure date.

4 Authorised Signatory

- (a) A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.

5 Submission of Bid

- (a) The bid must be put in a sealed envelope, or envelopes when the two-envelope system is specified, clearly marked with the bid number, title as well as closing date and time and placed in the Tender Box at the Garden Route District Municipality by not later than 11h00 on 20 September 2019.
- (b) Faxed, e-mailed and late bids will not be accepted. Bids may be delivered by hand, by courier, or posted at the bidder's risk and must be received by the deadline specified above, irrespective of how they are sent or delivered.

6 Opening, Recording and Publications of Bids Received.

- Bids will be opened in public immediately after the bid closure date, or at such
- time as specified in the bid documents. If requested by any bidder present,
- names of the bidders, and if practical the total amount of each bid and of any alternative bids will be read out loud.
- Bids received in time recorded and entered in a register which is open for public inspection.

7 Tax Clearance Certificate

- a. A valid original Tax Clearance Certificate must accompany the bid documents.
 - The onus is on the bidder to ensure that the Garden Route District Municipality has an original Tax <u>Clearance Certificate on record</u> and obtain confirmation from the Supply Chain Management Unit of the Garden Route District Municipality.
- b. Bids not supported by a valid original Tax Clearance Certificate, as an attachment to the bid documents will be invalidated.
- c. In bids where consortia/joint ventures/sub-contractors are involved, each party must submit a separate valid original Tax Clearance Certificate.

8 Evaluation of Bids

Bids will be evaluated in terms of their responsiveness to the bid specifications and requirements as well as such additional criteria as set out in the bid documents.

9 Acceptance or Rejection of a Bids

The Garden Route District Municipality reserves the right to withdraw any invitation to submit a bid and/or to re-advertise or to reject any bid or to accept a part of it. The Garden Route District Municipality does not bind itself to accepting the lowest bid.

10 Registration on Accredited Supplier Database

It is expected of all prospective service providers who are not yet registered on the Central Supplier Database to register online (<u>www.csd.gov.za</u>) and verify their company information at Garden Route District Municipality Database Department. The Garden Route District Municipality reserves the right not to award proposals to prospective suppliers who are not registered on the CSD (Central Supplier Database).

11 Site / Information Meetings

12 Stamp and Other Duties

The successful bidder will be liable for all duties and costs on legal documents resulting in the establishment of a contract and for the surety and retentions.

13 Language of Contract

The contract documents will be compiled in English and the English versions of all referred documents will be taken as applicable.

14 Procurement Policy

Bids will be awarded in accordance with the Preferential Procurement Regulations, 2017 pertaining to the Preferential Procurement Policy Framework Act, No 5 of 2000.

15 Expenses Incurred in Preparation of Bid

The Garden Route District Municipality shall not be liable for any expenses incurred in the preparation and submission of the bid.

16 Wrong Information Furnished

Where a contract has been awarded on the strength of the information furnished by the bidder which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Garden Route District Municipality may, in addition to any other legal remedy it may have, recover from the contractor all costs, losses or damages incurred or sustained by the Municipality as a result of the award of the contract.

17 Validity Period

Bids shall remain valid for 90 days after the bid closure date.

18 General and Special Conditions of Contract

The General Conditions of Contract as well as any Special Conditions of Contract that may form part of this set of bid documents will be applicable to this bid in addition to the conditions of bid.

19 Municipal Rates, Taxes and Charges

The bidder to provide their municipal account of rates and taxes of both the Bidding entity and its directors' in its Bid Document submission. Any bidder which is or whose directors are in arrear with their municipal rates and taxes due to any Municipality within South Africa for more than three months and have not made an arrangement for settlement of or same before the bid closure date will be disgualified.

20 Contact with Municipality after Bid Closure Date

REMOVAL OF DOMESTIC WASTE FROM THE FRANSMANSHOEK RECREATIONAL AREA

SECTION: SPECIFICATIONS

1. Introduction

The Garden Route District Municipality ("GRDM") invites service providers that are within the waste removal industry to submit a Tender for domestic waste removal services required in the Fransmanshoek recreational area, Vleesbaai, GPS Coordinates: Y -45382.0; X +59854.1.

2. Minimum Requirements

The following minimum requirements are applicable to this tender:

- 2.1 Proof of agreement with licensed / permitted waste disposal facility:
 - a) The bidder must obtain an agreement letter from a Landfill owner licensed / permitted by the Department of Environmental Affairs and Development Planning for the disposal of collected waste.
 - b) The bidder must attach a copy of this agreement as evidence.
- 2.2. Proof of ownership of appropriate waste removal vehicle:
 - a) The vehicles used to transport waste needs to adhere to the stipulations within the National Road Traffic Act No. 93 of 1996 and any other appropriate road transport legislation currently in place. This Act pertains to the fact that all vehicles should be in a fully roadworthy condition and should have an up-to-date license registration.
 - b) Waste transported must be covered with adequate covers such as tarpaulins or netting, or sealed to prevent the waste from falling off or blowing off vehicles whilst in transit.
 - c) If nets are to be used, the aperture size must be smaller than the waste particle size to prevent the waste escaping through the net. The net or cover must be properly fastened to the vehicle or waste container.
 - d) Precautions shall be taken to prevent spillage or leakage during transportation from all vehicles used to collect and/or transport municipal solid wastes that produces leachate.
 - e) Any waste spillage that occurs during the collection and transport of waste must be cleaned up immediately. No transportation may continue should waste be observed to be falling out of the transportation vehicle, but driver must stop and secure waste to prevent waste spillage.
 - f) The successful bidder must be registered on the Garden Route Waste Management Information System as a Waste Transporter and must report the waste quantities removed on a monthly basis.
 - g) The bidder should attach a copy of the up-to-date license registration as well as photographic evidence of the vehicle's compliance with the requirements as in points b) and c) above.

All bids that fail to attach the required documentation shall not be considered for further evaluation.

3. Number of Bins

There are currently twelve (12) x 150 litre plastic swinging refuse containers mounted on double poles at the Fransmanshoek peninsula that must be emptied and removed by the service provider.

Refuse removal

- 3.1 This contract will be awarded for a period of three (3) year from 01 December 2019 to 30 November 2022.
- 3.2 Waste removal must take place at the following frequencies:

3.3 Removal must take place on a Monday morning before 12h00; and where removal is done twice a week; on a Thursday morning before 12h00.

3.4 The successful bidder must avail him/herself with the necessary equipment in order to empty the containers and remove the waste in such a way to prevent any windblown litter.

3.7 If any windblown litter occurs during the waste removal services, the windblown litter must be cleaned up immediately.

3.8 It is the responsibility of the successful bidder to ensure that they have the adequate number of employees, vehicles and any other equipment that may be needed to render the service satisfactorily.

3.9 It is also the responsibility of the successful bidder to have an alternative plan in the event of any problems that may occur.

3.10 Equipment used to remove and handle the waste must be suitable for the purpose of this tender. The equipment used must be to the satisfaction of this Council as well as the owner of the landfill site to be used.

4. Recycling

4.1 Due to the set out purpose associated with the Fransmanshoek recreational area, a large amount of recyclable material is generated and must be recovered from the waste prior to disposal at the licensed landfill site.

4.2 The successful bidder must compile and implement a recycling programme to recover all the recyclable materials from the refuse as far as possible. The successful bidder must provide Garden Route District Municipality with statistics on the recyclables removed with his/her monthly invoice to the Municipality.

5. General

5.1 The Municipality reserves the right to cancel the contract if the service is not provided to its satisfaction or if any of the contract conditions are breached. A notice will be given to the successful bidder, in writing, to correct the non- compliance within two (2) days. If the successful bidder still does not comply, the Municipality reserves the right to take the necessary measures to deliver the service. This will be for the cost of the successful bidder.

5.2 The successful bidder must indemnify the Municipality from any actions, lawsuits, proceedings, claims, demands, costs, damages and expenses that may occur or be brought against the Municipality in rendering this or as a result of rendering this service.

5.3 Payment will only be made within 30 days after the services have been rendered and to the satisfaction of the Executive Manager: Community Services or his delegate.
