**1 Agreement**

The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by the Garden Route District Municipality that his/her bid has been accepted.

**2 Completion of Bid Documents**

- (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
- (b) Bid documents may not be retyped or altered in any way.

**3 Alteration or Qualification of Bid**

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before the closure date.

**4 Authorised Signatory**

- (a) A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.

**5 Submission of Bid**

- (a) The bid must be put in a sealed envelope, or envelopes when the two-envelope system is specified, clearly marked with the bid number, title as well as closing date and time and placed in the **Tender Box at the Garden Route District Municipality by not later than 11h00 on 04 October 2019.**
- (b) Faxed, e-mailed and late bids will not be accepted. Bids may be delivered by hand, by courier, or posted at the bidder's risk and must be received by the deadline specified above, irrespective of how they are sent or delivered.

**6 Opening, Recording and Publications of Bids Received.**

- names of the bidders, and if practical the total amount of each bid and of any alternative bids will be read out loud.
- Bids received in time recorded and entered in a register which is open for public inspection.

**7 Tax Clearance Certificate**

- a. A valid original Tax Clearance Certificate must accompany the bid documents. The onus is on the bidder to ensure that the Garden Route District Municipality has an original Tax Clearance Certificate on record and obtain confirmation from the Supply Chain Management Unit of the Garden Route District Municipality.

**Specifications:**

**1. Scope:**

The required equipment is a firefighting pump that has a self-contained petrol engine unit designed for continuous operation at the maximum rated output and is capable of running at maximum performance immediately after starting from cold.

**2. Engine**

**a) General**

- i) 2 vertical in-line cylinder, horizontal crankshaft, 4 stroke water cooled petrol engine.
- ii) Engine capacity to be up to 900cc.
- iii) Engine to develop up to 40kW
- iv) Dry-sump configuration - the complete unit can be operated at an angle of 30° to the horizontal in all directions.

**b) Cooling**

The closed circuit cooling system is to utilize a heat exchanger of sufficient capacity to maintain correct engine operating temperature even when operating in high ambient temperatures of 45°C water and 55°C air.

The heat-exchanger is to be packaged with the coolant header tank for compactness.

**c) Fuel**

The fuel tank is to have has a capacity adequate to allow pumping at full rating for at least 1 hour.

The fuel gauge that is fitted on the pump is to be a high visibility LED type that includes a red low level (<1/4 tank) light for easy visibility of a low-fuel condition.

**d) Electrical System**

The pump is to have 12 volt electric starting.

The pump is to be fitted with a low maintenance 12 volt battery.

The engine is to be equipped with an integrated cylinder decompression system to ensure easy hand starting when required.

The battery terminals are to be covered to prevent accidental discharge and for operator protection.

**e) Exhaust**

A stainless steel exhaust silencer is to be fitted with a heat shield to reduce the possibility of operator injury.

**3. Rated Performance**

1000 l/min at 10 bar at 3 m static suction lift. (Max. performance 1200 l/m at 10 bar)



#### **4. Water Inlet**

Single stage centrifugal directly mounted to the engine.

The body is to be manufactured from aluminium alloy or gunmetal as an option.

The suction tube connection is to be 100mm (4") British Standard round thread or 4½" BSP suction tube for local connectors. A long life self-adjusting mechanical seal is to be fitted which consists of a carbon ring running on a silicon carbide face.

## General Conditions of Contract

### **1. Definitions**

1. The following terms shall be interpreted as indicated:
  - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
  - 1.2 "Contract" means the written agreement entered into between the purchaser and the provider, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
  - 1.3 "Contract price" means the price payable to the provider under the contract for the full and proper performance of his contractual obligations.
  - 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
  - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
  - 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied.
