Department of Community Safety: Vision and Mission

Vision:

 A safer open opportunity society for all whilst building resilient communities which are responsive to safety needs

Mission:

 The Department of Community Safety aims to increase safety for all in the Province by promoting professional policing through effective oversight and by facilitating safety partnerships and programmes to build greater safety and security organisational resilience.







District Safety Approach

- DoCS has been allocated funds over four-years to support district municipalities to attain safety objectives.
- The Department of Community Safety will develop a resilience model in order to build safe & cohesive communities for each District Municipality













District Safety Approach (cont.)

- DMs must develop a district safety plan and spend funds in accordance with the plan. They must also appoint a coordinator, train and deploy mediators to address social unrest, and provide quarterly reports to DoCS.
- This can be monitored through the municipal safety structure.















District Municipality Approach (cont.)

- Mediation teams trained and established in Overberg District
 & Garden Route
- Coordinators appointed in Overberg and Garden Route.
- Set up quarterly meetings with Executive Mayors & Municipal Managers
- Provincial District approach regular participation in PCF and DCF fora.

Neighbourhood Watch – Eden District & Da Gamaskop

 Currently 46 accredited NHWs in the Eden & Da Gamaskop SAPS Clusters;

All accredited NWHs received:

- accreditation certificates,
- Starter Kits (consisting of reflective vests, strobe lights, torches, magnetic decals for the vehicles, First Aid Kit, Fire Extinguisher, safety whistles and a storage box) and T-shirts and caps;

Benefits of accreditation

- free training in your community ie. Basic NHW Training,
 First Aid (Level 1) and Basic Fire fighting;
- qualify for funding (R10 000) towards their operational and administrative costs;

Neighbourhood Watch – Eden District & Da Gamaskop

- In August, DOCs held an event in George where the process for the Professionalisation of NHWs was explained;
- New brand for Neighbourhood Watches was introduced;

 New Neighbourhood Watch Management System (NHWMS) where members of the public can apply

online for accreditation was introduced, &

 New Communication and Reporting application (ie.Kaizala) that is currently being piloted, was introduced.

Provincial Priorities

Based on the Premier's State of the Province address in July 2019, five strategic priorities were identified:

- 1. Enabling economy and creating a job in every household
- 2. Empowering people
- 3. Public transport, Mobility and Spatial Transformation
- 4. Safe and cohesive communities
- 5. Innovation across government and Culture Change in the Western Cape

Strategic case documents are in process of development for each one, identified areas for action and engagement, and outcome indicators.



Apex Safety Priorities for the Western Cape

Premier Allan Winde announced on 19 September 2019:

- Vision to halve the murder rate in the Province within 10 years
- Each MEC has been allocated certain safety priorities
- The implementation will be coordinated through the Premier's Safety Cabinet:
 - Ministers, SAPS and other stakeholders in the Criminal Justice
 System will be held accountable for delivery metrics
- The safety initiatives will follow a data driven approach.
- The detailed safety plan is still under development.

Community Safety (MEC Fritz)	 Training & deployment of 3000 law enforcement officers (City of Cape Town) Deployment of 50 investigators in high crime areas Expand Chrysalis academy interventions Enhance police oversight Change legislation to ensure cheap alcohol pricing amended.
Social Development (MEC Fernandez)	 Identifying, profiling & supporting youth at risk of violent or criminal behaviour Deliver parenting programmes to reduce violence, GBV and substance abuse
