1 Agreement

The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by the Garden Route District Municipality that his/her bid has been accepted.

2 Completion of Bid Documents

- (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
- (b) Bid documents may not be retyped or altered in any way.

3 Alteration or Qualification of Bid

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before the closure date.

4 Authorised Signatory

- (a) A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.

5 Submission of Bid

- (a) The bid must be put in a sealed envelope, or envelopes when the two-envelope system is specified, clearly marked with the bid number, title as well as closing date and time and placed in the **Tender Box at the Garden Route District Municipality by not later than 11h00 on 18 September 2020.**
- (b) Faxed, e-mailed and late bids will not be accepted. Bids may be delivered by hand, by courier, or posted at the bidder's risk and must be received by the deadline specified above, irrespective of how they are sent or delivered.

- Bids received in time recorded and entered in a register which is open for public inspection.

7 Tax Clearance Certificate

- a. A valid original Tax Clearance Certificate must accompany the bid documents.

17 Validity Period

18 General and Special Conditions of Contract

TERMS OF REFERENCE

THE GARDEN ROUTE DISTRICT MUNICIPALITY SEEK TO APPOINT A SUPPLIER TO DELIVER REPAIR AND INSTALL TWO WAY RADIO COMMUNICATION DEVICES, AND CONTROL ROOM SUPPORT SYSTEMS. INVITATION TO TENDER FOR TWO WAY RADIO COMMUNICATION THREE YEAR TENDER

SCOPE

The Garden Route District Municipality operates a digital radio infrastructure platform for its roads, fire as well as disaster management services, the existing tender has come to an end as of 30 June 2019 and thus we seek the services of a service provider to assist with support, maintenance of the existing network and for any future expansion. The existing network consist of various sites providing coverage spanning on the Southern boundary from Knysna to the East and Riversdale to the West with a centrally located call centre in George and on the Northern boundary from Ladismith in the West to Haarlem in the East. The current two way radio service provides coverage for our essential service radio network. The service provider must also be able to provide a channel that, in the event of a disaster, would allow the Garden Route District Municipality emergency services to communicate with all emergency services in the Western Cape that is operated on a Digital Radio Communication network.

PURPOSE

- To obtain a support company to provide support for the exiting municipal radios and repeaters;
- Provide additional site rental options for the expansion of the current network;
- Provide for new installations for network growth and coverage;
- Provide guidance strategic roadmap through experience and knowledge of the sector technology;

TENDER SPECIFICATION

3.1 A pre-qualification will apply to this tender with the following conditions

- 3.1.1 Bidder must have an accredited two-way radio workshop. (This workshop may be inspected by the Garden Route District Municipality for approval);
- 3.1.2 The workshop must be within a **200 km** range from George and it must be able to provide for the parking of trucks in order to do installations and repairs when required;
- 3.1.3 Maintenance and Service must be provided within any 48-hour period when required.
- 3.1.4 Bidder must be Authorised Reseller for the products – **(provide supporting letter/proof)**
- 3.1.5 Radio equipment offer must be compatible with the existing Motorola Digital DMR equipment used by the Garden Route District Municipality.
- 3.1.6 Where applicable, equipment in workshop must be ICASA approved.

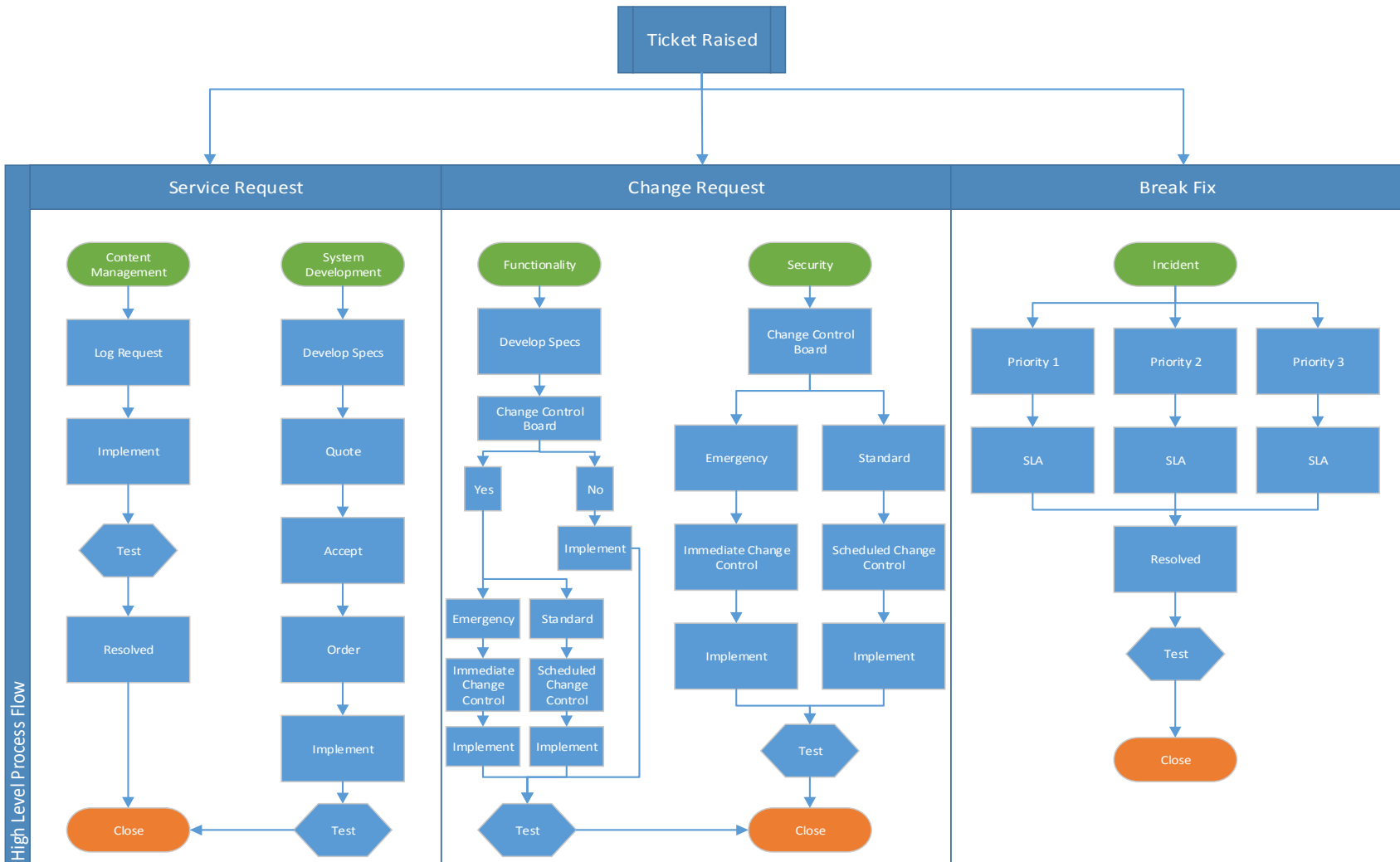

² Bid rigging (or collusive bidding) occurs when businesses, that would otherwise be expected to compete, secretly conspire to raise prices or lower the quality of goods and / or services for purchasers who wish to acquire goods and / or services through a bidding process. 1. Definitions

1. The following terms shall be interpreted as indicated:
 - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2 "Contract" means the written agreement entered into between the purchaser and the provider, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3 "Contract price" means the price payable to the provider under the contract for the full and proper performance of his contractual obligations.
 - 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
 - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
 - 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
 - 1.7 "Day" means calendar day.
 - 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
 - 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
 - 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the provider bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.

Settlement of Disputes	<p>28.1 If any dispute or difference of any kind whatsoever arises between the purchaser and the provider in connection with or arising out of the contract, the parties shall make every effort to resolve amicably such dispute or difference by mutual consultation.</p> <p>28.2 If, after thirty (30) days, the parties have failed to resolve their dispute or difference by such mutual consultation, then either the purchaser or the provider may give notice to the other party of his intention to commence with mediation. 30. Governing language	30.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.
31. Applicable law	31.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified.
32. Notices	<p>32.1 Every written acceptance of a bid shall be posted to the provider concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice.</p> <p>32.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.</p>

Amendment of contracts	35.1 No agreement to amend or vary a contract or order or the conditions, stipulations or provisions thereof shall be valid and of any force unless such agreement to amend or vary is entered into in writing and signed by the contracting parties. Any waiver of the requirement that the agreement to amend or vary shall be in writing, shall also be in writing.
