#### **BID CONDITIONS AND INFORMATION**

#### 1 Agreement

The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by the Garden Route District Municipality that his/her bid has been accepted.

#### 2 Completion of Bid Documents

- (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
- (b) Bid documents may not be retyped or altered in any way.

#### 3 Alteration or Qualification of Bid

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before the closure date.

#### 4 Authorised Signatory

- (a) A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.

#### 5 Submission of Bid

- (a) The bid must be put in a sealed envelope, or envelopes when the two-envelope system is specified, clearly marked with the bid number, title as well as closing date and time and placed in the **Tender Box** at the Garden Route District Municipality by not later than 11h00 on 15 December 2020.
- (b) Faxed, e-mailed and late bids will not be accepted. Bids may be delivered by hand, by courier, or posted at the bidder's risk and must be received by the deadline specified above, irrespective of how they are sent or delivered.

#### 6 Opening, Recording and Publications of Bids Received.

- Bids will be opened in public immediately after the bid closure date, or at such
- time as specified in the bid documents. If requested by any bidder present,
- names of the bidders, and if practical the total amount of each bid and of any alternative bids will be read out aloud.
- Bids received in time recorded and entered in a register which is open for public inspection.

#### 7 Tax Clearance Certificate

- a. A valid original Tax Clearance Certificate must accompany the bid documents. <u>The onus is on the bidder to ensure that the Eden District Municipality has an original Tax Clearance</u> <u>Certificate on record</u> and obtain confirmation from the Supply Chain Management Unit of the Garden Route District Municipality.
- b. Bids not supported by a valid original Tax Clearance Certificate, as an attachment to the bid documents will be invalidated.
- c. In bids where consortia/joint ventures/sub-contractors are involved, each party must submit a separate valid original Tax Clearance Certificate.

#### 8 Evaluation of Bids

Bids will be evaluated in terms of their responsiveness to the bid specifications and requirements as well as such additional criteria as set out in the bid documents.

#### 9 Acceptance or Rejection of a Bids

The Garden Route District Municipality reserves the right to withdraw any invitation to submit a bid and/or to readvertise or to reject any bid or to accept a part of it. The Garden Route District Municipality does not bind itself to accepting the lowest bid.

#### 10 Registration on Accredited Supplier Database

It is expected of all prospective service providers who are not yet registered on the Central Supplier Database to register online (<u>www.csd.gov.za</u>) and verify their company information at Garden Route District Municipality Database Department. The Garden Route District Municipality reserves the right not to award proposals to prospective suppliers who are not registered on the CSD (Central Supplier Database).

#### 11 Site / Information Meetings No site meeting held.

#### 12 Stamp and Other Duties

The successful bidder will be liable for all duties and costs on legal documents resulting in the establishment of a contract and for the surety and retentions.

#### 13 Language of Contract

The contract documents will be compiled in English and the English versions of all referred documents will be taken as applicable.

#### 14 Procurement Policy

Bids will be awarded in accordance with the Preferential Procurement Regulations, 2001 pertaining to the Preferential Procurement Policy Framework Act, No 5 of 2000.

#### 15 Expenses Incurred in Preparation of Bid

The Garden Route District Municipality shall not be liable for any expenses incurred in the preparation and submission of the bid.

#### 16 Wrong Information Furnished

Where a contract has been awarded on the strength of the information furnished by the bidder which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Garden Route District Municipality may, in addition to any other legal remedy it may have, recover from the contractor all costs, losses or damages incurred or sustained by the Municipality as a result of the award of the contract.

#### 17 Validity Period

Bids shall remain valid for 90 days after the bid closure date.

#### 18 General and Special Conditions of Contract

The General Conditions of Contract as well as any Special Conditions of Contract that may form part of this set of bid documents will be applicable to this bid in addition to the conditions of bid.

#### 19 Municipal Rates, Taxes and Charges

# BACKGROUND

The Skills Workstream was established under the Garden Route Rebuild Initiative (GRRI) after the devastating Knysna fires in 2017. A need was identified for people to be re-skilled or up-skilled due to the fact that many lost their jobs mainly linked to the Tourism industry. This also created opportunities for new skills to be introduced as part of the rebuild and re-generation process.

The most critical requirement to move the Garden Route Skills Mecca catalytic flagship project forward is the appointment of a Service Provider to fully develop the "skills mecca" concept and relevant implementation processes.

The GRDM, therefore, invites suitably qualified services provides to respond to this Request to submit proposal for the coordination of the Skills Mecca project across the Garden Route.

The successful respondents should have the capacity and expertise to meet the requirements of GRDM in as far as these services are concerned.

#### **OBJECTIVES AND SCOPE OF WORK**

- The objective of the assignment is to ensure that **the following** is carried out for the Garden Route Skills Mecca catalytic flagship project, utilizing human and financial resources made available by District and Local Municipalities:
  - a. Fully conceptualize the garden route skills mecca flagship;
  - b. Develop a value proposition for garden route skills mecca;
  - c. Develop business cases, implementation plans for potential partnerships and Identify potential partners and engage with them to establish presence in the District;
  - d. Develop and where possible implement an eMarketing Strategy and Campaign for the Garden Route Skills Mecca;
  - e. Identify key stakeholders and sub-initiative leads;
  - f. Provide relevant technical inputs, on skills development within the Garden Route;
  - g. Ensure flagship project is execution ready with all relevant information properly documents for handover to the District and local Municipalities at end of contract period;
  - h. Report back to relevant stakeholders;
  - i. Source funding for full implementation of this project.
- 2. Support administration of the quarterly Skills Mecca Task Team meeting and serve as technical advisor.
