#### **BID CONDITIONS AND INFORMATION**

#### 1 Agreement

The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by the Garden Route District Municipality that his/her bid has been accepted.

#### 2 Completion of Bid Documents

- (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
- (b) Bid documents may not be retyped or altered in any way.

#### 3 Alteration or Qualification of Bid

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before the closure date.

#### 4 Authorised Signatory

- (a) A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.

#### 5 Submission of Bid

#### 12 Stamp and Other Duties

#### 13 Language of Contract

#### 14 Procurement Policy

#### 16 Wrong Information Furnished

Where a contract has been awarded on the strength of the information furnished by the bidder which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Garden Route District Municipality may, in addition to any other legal remedy it may have, recover from the contractor all costs, losses or damages incurred or sustained by the Municipality as a result of the award of the contract.

#### 17 Validity Period

Bids shall remain valid for 90 days after the bid closure date.

#### 18 General and Special Conditions of Contract

The General Conditions of Contract as well as any Special Conditions of Contract that may form part of this set of bid documents will be applicable to this bid in addition to the conditions of bid.

#### 19 Municipal Rates, Taxes and Charges

# 1. **SPECIFICATIONS**

Garden Route District Municipality wishes to appoint a panel of registered professional Psychologists / Psychiatrists / Occupational Therapists / Nutritionists / Social Workers and Mental health Counsellors for the rendering of counselling services to Garden Route District Municipality. These panels will be used on rotational basis as and when related services are required. The service will be rendered in these following towns in the Garden Route District Municipality jurisdiction:

- George
- Knysna
- Riversdale
- Oudtshoorn

## 1. MINIMUM REQUIREMENTS

- 2.1 Professionals should have an updated registration at the Health Professions Council of South Africa (HPCSA) or other relevant Professional Board.
- 2.2 Bidder must attach certified copies of professional registrations and qualifications.
- 2.3 Bidder must submit registration documents of the company and Identity document.
- 2.4 All the Registered Psychologists, Psychiatrists, Occupational Therapists and counsellors must have an office in the Garden Route District Municipal Area.

#### **General Conditions of Contract**

#### 1. Definitions

- 1. The following terms shall be interpreted as indicated:
- 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2 "Contract" means the written agreement entered into between the purchaser and the provider, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3 "Contract price" means the price payable to the provider under the contract for the full and proper performance of his contractual obligations.
- 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7 "Day" means calendar day.
- 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
- 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
