#### **BID CONDITIONS AND INFORMATION**

#### 1 Agreement

The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by the Garden Route District Municipality that his/her bid has been accepted.

#### 2 Completion of Bid Documents

- (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
- (b) Bid documents may not be retyped or altered in any way.

#### 3 Alteration or Qualification of Bid

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before the closure date.

#### 4 Authorised Signatory

- (a) A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.

#### 5 Submission of Bid

- (a) The bid must be put in a sealed envelope, or envelopes when the two-envelope system is specified, clearly marked with the bid number, title as well as closing date and time and placed in the Tender Box at the Garden Route District Municipality by not later than 11h00 on 29 March 2021.
- (b) Faxed, e-mailed and late bids will not be accepted. Bids may be delivered by hand, by courier, or posted at the bidder's risk and must be received by the deadline specified above, irrespective of how they are sent or delivered.

#### 6 Opening, Recording and Publications of Bids Received.

- Bids will be opened in public immediately after the bid closure date, or at such
- time as specified in the bid documents. If requested by any bidder present,
- names of the bidders, and if practical the total amount of each bid and of any alternative bids will be read out loud.
- Bids received in time recorded and entered in a register which is open for public inspection.

#### 7 Tax Clearance Certificate

- A valid original Tax Clearance Certificate must accompany the bid documents. <u>The onus is on the bidder to ensure that the Garden Route District Municipality has an original Tax Clearance</u> <u>Certificate on record</u> and obtain confirmation from the Supply Chain Management Unit of the Garden Route District Municipality.
- b. Bids not supported by a valid original Tax Clearance Certificate, as an attachment to the bid documents will be invalidated.
- c. In bids where consortia/joint ventures/sub-contractors are involved, each party must submit a separate valid original Tax Clearance Certificate.

#### 8 Evaluation of Bids

Bids will be evaluated in terms of their responsiveness to the bid specifications and requirements as well as such additional criteria as set out in the bid documents.

#### 9 Acceptance or Rejection of a Bids

The Garden Route District Municipality reserves the right to withdraw any invitation to submit a bid and/or to re-advertise or to reject any bid or to accept a part of it. The Garden Route District Municipality does not bind itself to accepting the lowest bid.

#### 10 Registration on Accredited Supplier Database

It is expected of all prospective service providers who are not yet registered on the Central Supplier Database to register online (<u>www.csd.gov.za</u>) and verify their company information at Garden Route District Municipality Database Department. The Garden Route District Municipality reserves the right not to award proposals to prospective suppliers who are not registered on the CSD (Central Supplier Database).

#### 12 Stamp and Other Duties

The successful bidder will be liable for all duties and costs on legal documents resulting in the establishment of a contract and for the surety and retentions.

#### 13 Language of Contract

The contract documents will be compiled in English and the English versions of all referred documents will be taken as applicable.

#### 14 Procurement Policy

Bids will be awarded in accordance with the Preferential Procurement Regulations, 2017 pertaining to the Preferential Procurement Policy Framework Act, No 5 of 2000.

#### 15 Expenses Incurred in Preparation of Bid

The Garden Route District Municipality shall not be liable for any expenses incurred in the preparation and submission of the bid.

#### 16 Wrong Information Furnished

Where a contract has been awarded on the strength of the information furnished by the bidder which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Garden Route District Municipality may, in addition to any other legal remedy it may have, recover from the contractor all costs, losses or damages incurred or sustained by the Municipality as a result of the award of the contract.

#### 17 Validity Period

Bids shall remain valid for 90 days after the bid closure date.

#### 18 General and Special Conditions of Contract

The General Conditions of Contract as well as any Special Conditions of Contract that may form part of this set of bid documents will be applicable to this bid in addition to the conditions of bid.

#### 19 Municipal Rates, Taxes and Charges

#### 1. INTRODUCTION

The purpose of the tender is to appoint a service provider for the hiring of a mechanical road marking machine.

#### 2. DEFINITION

The marking of road surfaces with painted lines and symbols with the use of a mechanical road marking machine.

#### 3. DEMARCATION

The Garden Route District Municipality region and Central Karoo municipal region.

#### 4. PRICE

Price must be fixed for each year over a three year period and must be inclusive of all costs as contained in the price schedule.

#### 5. DELIVERY PERIOD

Road Marking Machine should be made available within 3 weeks after an order has been issued.

#### 6. PAINT

All paint and/or retro-reflective beads (where applicable) will be supplied by the Garden Route District Municipality.

#### 7. SCOPE OF WORK

- 7.1 The mechanical road-marking machine shall be capable of painting at least three lines simultaneously and shall apply the paint to a uniform film thickness at the rates of application specified.
- 7.2 The machine shall be so designed that it will be capable of painting the road markings everywhere to a uniform width with sides within the tolerances specified without the paint running or splashing or spattering.
- 7.3 The machine shall further be capable of painting lines of different widths by adjusting the spray jets on the machine or by means of additional equipment attached to the machine.
- 7.4 Where two or three lines are required next to each other, the lines shall be applied simultaneously by the same machine.
- 7.5 Where retro-reflective paint is required, the retro-reflective beads shall be applied by means of a suitable machine in one continuous operation, immediately after the paint has been applied.
- 7.6 Machines which apply the beads by means of gravity only shall not be used. The beads shall be sprayed onto the paint layer by means of a pressure sprayer.

#### 8. TOLERANCES

- 8.1 Width: The width of lines and other markings shall not be less than the specified width, nor shall it exceed the specified width by more than 10mm.
- 8.2 **Position**: The position of lines, letters, figures, arrows, retro-reflective road studs and other markings shall not deviate from the true position by more than 100mm in die longitudinal and 20mm in the transverse direction
- 8.3 Alignment of markings: The alignment of the edges of longitudinal lines shall not deviate from the true alignment by more than 10 mm in 15 metre.
- 8.4 Broken lines: The lengths of segments of broken longitudinal lines shall not deviate by more than 150 mm from the specified length.

#### 9. PERSONNEL MANAGEMENT

**Tender Document** 

- 9.1 Road marking machine should include an operator and assistant (gun checker) and should be supplied with own diesel.
- 9.2 All operators must comply with legislative requirements, health and safety procedures and subsequently licenced for the appropriate machine.
- 9.3 Tenderer should supply own transport equipment and operator to transport road marking machine between road projects.
- 9.4 Accommodation for operators and assistant must be provided by the tenderer.
- 9.5 Traffic accommodation will be provided by the Garden Route District Municipality.




