**1 Agreement**

The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by the Garden Route District Municipality that his/her bid has been accepted.

**2 Completion of Bid Documents**

- (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
- (b) Bid documents may not be retyped or altered in any way.

**3 Alteration or Qualification of Bid**

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before the closure date.

**4 Authorised Signatory**

- (a) A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.

**5 Submission of Bid**

## TERMS OF REFERENCE

### **Garden Route District Municipality SUPPLY AND DELIVERY OF PASSIVE AIR QUALITY SAMPLING SERVICE AIR QUALITY MANAGEMENT UNIT THREE YEARS**

#### **PURPOSE OF DOCUMENT**

The Air Quality unit is responsible for Air Quality monitoring in terms of the National Environmental Management: Air Quality Act, 39 of 2004 (as amended) as well as in terms of the National Framework and the Eden Air Quality Management Plan.

#### **SCOPE OF WORK/ SERVICE**

Tenders for the Supply of Air Quality passive sampling equipment as well as the analysis of the samples are required for a period of 3 years.

#### **TECHNICAL REQUIREMENTS**

1. Pricing must be provided as per Table 1.
2. Prices must be VAT inclusive. (VAT applicable only to VAT vendors)
3. Prices must be provided over a 3 year period including price escalation over the three year period.
4. Prices of cartridges must include the laboratory analysis and the sample report (results) in electronic format.
5. Prices must include the three monthly delivery of the samples to the district municipality as well as the monthly collection of the samples for analysis.

Pick-up Address = Mossel Bay

6. The analysis must be conducted in-house at a SANAS accredited laboratory.  
Provide proof of SANAS accreditation certificate.
7. Samples must be transported in dry ice packs.
8. Samples must be signed off by the Laboratory manager and reported on a laboratory report certifying that the samples were analyzed according to SANAS requirements.
9. Delivery time (turnaround-time) of samples: Electronic report must be



submitted within 10-15 working days starting on date of receipt of samples.

10. All above tests must be performed in accordance with the applicable standard test methods as published by NIOSH, OHSA and EPA.

11. Tenderers will be awarded for three years in terms of a contract between the municipality and the vendor.

12. Please provide the Brand name of the Air Quality Passive samplers in the tender.

## General Conditions of Contract

### **1. Definitions**

1. The following terms shall be interpreted as indicated:
  - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
  - 1.2 "Contract" means the written agreement entered into between the purchaser and the provider, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
  - 1.3 "Contract price" means the price payable to the provider under the contract for the full and proper performance of his contractual obligations.
  - 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
  - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
  - 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
  - 1.7 "Day" means calendar day.
  - 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
  - 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
  - 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the provider bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
  - 1.11 "Dumping" occurs when a private enterprise abroad market its goods on own initiative in the RSA at lower prices than that of the country of origin and which have the potential to harm the local industries in the RSA.
  - 1.12 "Force majeure" means an event beyond the control of the provider and not involving the provider's fault or negligence and not foreseeable. Such events may include, but is not restricted to, acts of the purchaser in its sovereign capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes.
  - 1.13 "Fraudulent practice" means a misrepresentation of facts in order to influence a procurement process or the execution of a contract to the detriment of any bidder, and includes collusive practice among bidders (prior to or after bid submission) designed to establish bid prices at artificial non-competitive levels and to deprive the bidder of the benefits of free and open competition.
