Tender document & supporting documents must be placed in a sealed envelope clearly marked for "GRDM/22/20-21 DESIGN, MANUFACTURE, SUPPLY, INSTALLATION, COMMISSIONING AND TESTING, AND INITIAL MAINTENANCE OF A 90 KWP GRID TIED PV GENERATING PLANT AND A 50KW LITHIUM-ION BATTERY STORAGE SYSTEM AT THE DE HOEK RESORT, OUDTSHOORN" must be deposited in the tender box of the Garden District Municipality, Supply Chain Management Unit, 54 York Street, George.
- 3. Tenders may only be submitted on the tender document issues by the Municipality.

Tender evaluation will be done in three phases

Phase 1: Tenderers who scores 70% or more for functionality will go onto the phase 2 evaluation stage.

<u>Phase 2:</u> Tenderers selected from phase 1 will be invited to make oral presentation and at which the GRDM may pose specific questions relating to the tender and the work envisaged.

Phase 3: PPPFA

Tenderers will be evaluated and adjudicated in terms of the Preferential Procurement Policy Framework Act (Act 5 of 2000) Regulations **2017** and the Garden Route District Municipality Supply Chain Management Policy, where **80** points will be allocated in respect of price and **20** points in respect of BBBEE.
