1 Agreement

The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by the Garden Route District Municipality that his/her bid has been accepted.

2 Completion of Bid Documents

- (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
- (b) Bid documents may not be retyped or altered in any way.

3 Alteration or Qualification of Bid

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before the closure date.

4 Authorised Signatory

- (a) **A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.**
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.

5 Submission of Bid

- (a) The bid must be put in a sealed envelope, or envelopes when the two-envelope system is specified, clearly marked with the bid number, title as well as closing date and time and placed in the **Tender Box at the Garden Route District Municipality by not later than 11h00 on 09 July 2021.**
- (b) **Faxed, e-mailed and late bids will not be accepted. Bids may be delivered by hand, by courier, or posted at the bidder's risk and must be received by the deadline specified above, irrespective of how they are sent or delivered.**

6 Opening, Recording and Publications of Bids Received.

- Bids will be opened in public immediately after the bid closure date, or at such
- time as specified in the bid documents. If requested by any bidder present,
- names of the bidders, and if practical the total amount of each bid and of any alternative bids will be read out aloud.
- Bids received in time recorded and entered in a register which is open for public inspection.

7 Tax Clearance Certificate

- a. **A valid original Tax Clearance Certificate must accompany the bid documents.**
The onus is on the bidder to ensure that the Eden District Municipality has an original Tax Clearance Certificate on record and obtain confirmation from the Supply Chain Management Unit of the Garden Route District Municipality.
- b. **Bids not supported by a valid original Tax Clearance Certificate, as an attachment to the bid documents will be invalidated.**
- c. **In bids where consortia/joint ventures/sub-contractors are involved, each party must submit a separate valid original Tax Clearance Certificate.**

8 Evaluation of Bids

Bids will be evaluated in terms of their responsiveness to the bid specifications and requirements as well as such additional criteria as set out in the bid documents.

9 Acceptance or Rejection of a Bids

The Garden Route District Municipality reserves the right to withdraw any invitation to submit a bid and/or to re-advertise or to reject any bid or to accept a part of it. The Garden Route District Municipality does not bind itself to accepting the lowest bid.

10 Registration on Accredited Supplier Database

It is expected of all prospective service providers who are not yet registered on the Central Supplier Database to register online (www.csd.gov.za) and verify their company information at Garden Route District Municipality Database Department. The Garden Route District Municipality reserves the right not to award proposals to prospective suppliers who are not registered on the CSD (Central Supplier Database).

- 11 **Site / Information Meetings**
No site meeting held.
- 12 **Stamp and Other Duties**
The successful bidder will be liable for all duties and costs on legal documents resulting in the establishment of a contract and for the surety and retentions.
- 13 **Language of Contract**
The contract documents will be compiled in English and the English versions of all referred documents will be taken as applicable.
- 14 **Procurement Policy**
Bids will be awarded in accordance with the Preferential Procurement Regulations, 2001 pertaining to the Preferential Procurement Policy Framework Act, No 5 of 2000.
- 15 **Expenses Incurred in Preparation of Bid**
The Garden Route District Municipality shall not be liable for any expenses incurred in the preparation and submission of the bid.
- 16 **Wrong Information Furnished**
Where a contract has been awarded on the strength of the information furnished by the bidder which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Garden Route District Municipality may, in addition to any other legal remedy it may have, recover from the contractor all costs, losses or damages incurred or sustained by the Municipality as a result of the award of the contract.
- 17 **Validity Period**
Bids shall remain valid for 120 days after the bid closure date.
- 18 **General and Special Conditions of Contract**
The General Conditions of Contract as well as any Special Conditions of Contract that may form part of this set of bid documents will be applicable to this bid in addition to the conditions of bid.
- 19 **Municipal Rates, Taxes and Charges**
The bidder to provide their municipal account of rates and taxes of both the Bidding entity and its directors' in its Bid Document submission. Any bidder which is or whose directors are in arrear with their municipal rates and taxes due to any Municipality within South Africa for more than three months and have not made an arrangement for settlement of or same before the bid closure date will be disqualified.

TERMS OF REFERENCE

1. **INTRODUCTION**

- 1.1 A panel of three (3) successful bidder(s) will be expected to supply and deliver protective clothing items to the Garden Route District Municipality for the contract period of 3 years.
- 1.2 The submission of a tender signifies complete acceptance of the conditions contained in these instructions, the Form of Offer and the annexures.
- 1.3 Together with each tender submitted, it is requested that the lead times, manufacturer and calculations (pricing schedule) be submitted on a CD or USB Memory stick in a Microsoft Excel spread sheet.
- 1.4 Should there be any inconsistencies in the pricing between the CD or USB prices and the pricing entered in the tender document itself, the hand written price will be deemed to be correct.
- 1.5 Neither the CD nor the USB memory stick will be returned after the tender process is completed.

2. **SCOPE**

2.1 **Time**

Lead time will be 20 working days from date of order. If tenderer cannot supply within the specified lead time, order will be cancelled and second service provider will be contacted.

2.2 **Pricing**

- 2.2.1 All prices must include delivery and off-loading at respective stores mentioned in 4.1 below and must include VAT.
- 2.2.2 Price per item must include delivery to all three Depots listed in 4.1.
- 2.2.3 Prices should be fixed for a period of 3 years.

2.3 **Quality and quantities**

- 2.3.1 The manufacturer stated on the price schedule must remain the same over the three year period, unless it has closed down or for similar reasons.
- 2.3.2 Quality test: The Municipality may from time to time test the quality of the products and non-compliance with the original specifications may result in the termination of the contract. Should the Municipality suffer any losses due to substandard quality products (as agreed to) the supplier will be held responsible.
- 2.3.3 All product items should carry (minimum of one year) guarantees or warranties. Defects will be replaced at the expense of the supplier. The supplier will be responsible to ensure that the products are replaced and delivered.

3. **SAMPLES**

- 3.1 Only successful panel of bidders will be required to supply samples of ALL products.
- 3.2 Bidder's name must be clearly marked on all samples.
- 3.3 Samples must be handed in at the following address: Stores Division, Mission Street, George
- 3.4 The samples will be kept by Garden Route District Municipality Roads Department to verify/compare quality of future products.

4. **DELIVERIES**

- 4.1 The delivery addresses will be confirmed on the order as one of the following stores:
 - Oudtshoorn – Voortrekker Road
 - Riversdale – Vermaaklikheid Road
 - George – Mission Street
- 4.2 Delivery of products to the designated delivery addresses as indicated above must include the off-loading thereof at the supplier's own risk and cost.
- 4.3 Delivery must take place on normal business days between 08:00 and 16:00. Non-compliance hereto, could lead to the rejection of the delivery and the Garden Route DM will not be held responsible for any cost incurred.
- 4.4 Bidders must supply and ensure the availability of their own labour for the off-loading of the products at the designated municipal stores.

5. **ORDERS, INVOICING AND DELIVERY NOTES**

- 5.1 The District Municipality will place orders as and when required during the contract period.
- 5.2 An official order must be issued before any delivery may be made to the District Municipality.
- 5.3 It may be required from the supplier to keep stock of products or to ensure that full delivery takes place according to the order quantities.
- 5.4 All deliveries should be accompanied by at least a delivery note. The Garden Route DM reserves the right to reject the delivery without a delivery note.

1. Definitions

1. The following terms shall be interpreted as indicated:
 - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2 "Contract" means the written agreement entered into between the purchaser and the provider, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3 "Contract price" means the price payable to the provider under the contract for the full and proper performance of his contractual obligations.
 - 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
 - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
 - 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. 	22.5 Upon any delay beyond the delivery period in the case of a supplies contract, the purchaser shall, without cancelling the contract, be entitled to purchase supplies of a similar quality and up to the same quantity in substitution of the goods not supplied in conformity with the contract and to return any goods delivered later at the provider's expense and risk, or to cancel the contract and buy such goods as may be required to complete the contract and without prejudice to his other rights, be entitled to claim damages from the provider.
23. Penalties	23.1 Subject to GCC Clause 25, if the provider fails to deliver any or all of the goods or to perform the services within the period(s) specified in the contract, the purchaser shall, without prejudice to its other remedies under the contract, deduct from the contract price, as a penalty, a sum calculated on the delivered price of the delayed goods or unperformed services using the current prime interest rate calculated for each day of the delay until actual delivery or performance. The purchaser may also consider termination of the contract pursuant to GCC Clause 23.
24. Termination for default	24.1 The purchaser, without prejudice to any other remedy for breach of contract, by written notice of default sent to the provider, may terminate this contract in whole or in part: <ul style="list-style-type: none"> (a) if the provider fails to deliver any or all of the goods within the period(s) specified in the contract, or within any extension thereof granted by the purchaser pursuant to GCC Clause 22.2; (b) if the provider fails to perform any other obligation(s) under the contract; or (c) if the provider, in the judgement of the purchaser, has engaged in corrupt or fraudulent practices in competing for or in executing the contract. 24.2 In the event the purchaser terminates the contract in whole or in part, the purchaser may procure, upon such terms and in such manner as it deems appropriate, goods, works or services similar to those undelivered, and the provider shall be liable to the
