REPORT FROM MUNICIPAL MANAGER (GW LOUW)

PURPOSE OF THE REPORT

The purpose of the report is to inform Council about a vacancy in Eden District Council as a result of the resignation of proportional representative of ICOSA.

BACKGROUND

Council is advised that a vacancy has occurred on Eden District Council as a result of the resignation of the ICOSA representative on Eden Council, Mr. Bradley Benades.

Attached please find a copy from the letter I have received from Mr. Bradley Benades dated 08 August 2016 (*annexure A*).

The Independent Electoral Commission: Western Cape was informed of the vacancy as prescribed by section 11 of Schedule 2 of the Municipal Structures Act, 1998, Act 117 of 1998 on 15 August 2015.

Councillor T Fortuin has been declared elected as the new Proportional Representative for ICOSA on Eden District Council with effect 23 August 2016. A copy of the memorandum received from the IEC is attached as (*annexure B*).


