#### REPORT FROM MUNICIPAL MANAGER (MG STRATU)

#### **PURPOSE OF THE REPORT**

To inform Council of the replacement of Councillor S Odendaal who ceased to hold office as Councillor in the Garden Route District Council on 04 December 2018.

#### **BACKGROUND**

A vacancy occurred on Garden Route District Council as a result of the resignation of the Hessequa Municipal Council Representative on Garden District Council, Cllr. S Odendaal.

Section 11(1)(a) of Schedule 2 of the Municipal Structures Act, 1998 Act 117 of 1998, the Electoral Commission determines as follows:

"11 Filling of vacancies

(1)(a) If a Councillor elected from a party list ceases to hold office, the chief electoral officer, must subject to item 13, declare in writing the person whose name is on top of the applicable party list to be elected in the vacancy."

Section 13 of the said Act reads as follows:

"13 Filling of vacancies and changing the order

(1) A party may supplement, change or increase its list at any time, provided that if a Councillor elected according to a party list, ceases to hold office, the party concerned may supplement, change or increase its list by not later than 21 days after the Councillor has ceased to hold office. The vacancy must be filled as soon as the party in question has supplemented, changed or increased its list, but not later than 14 days expiry of the 21-day period."

The Provincial Independent Electoral Commission was informed of the vacancy as prescribed by section 11 of Schedule 2 of the Municipal Structures Act, 1998, Act 117 of 1998 on 13 December 2018.

The IEC has advised Council that Ms. **Theresia van Rensburg** (ID No 691220 0051 084) being the councillor for the Democratic Alliance (DA) in Hessequa Local Municipality, has been declared elected to the Garden Route District Council with effect from 10 January 2019. A copy of the notice dated 10 January 2019 from the IEC is attached as **annexure A**.

A copy of the extract from the minutes of the Council Meeting of Hessequa Municipality held on 04 December 2018 is attached as **annexure B**.

#### **RELEVANT LEGISLATION**

Schedule 2 of the Local Government Municipal Structures Act, 1998 (Act 117 of 1998).

#### **RECOMMENDATION**

- 1. That cognizance be taken of the notice from the IEC, dated 10 January 2019 as well as a letter from Hessequa Municipality dated 18 December 2018.
- 2. That Cllr T van Rensburg be inaugurated as Councillor of Garden Route District Council with effect from 10 January 2019.
- 3. That Cllr. T van Rensburg, be requested to take the Oath of Office, as required in terms the Municipal Structures Act, 1998.

#### REPORT FROM THE MUNICIPAL MANAGER (MG STRATU)

#### **PURPOSE OF THE REPORT**

The purpose of this report is to consider the outcomes of the recruitment and selection process as submitted by the Selection Panel and to recommend to Council as per resolutions below.

#### **BACKGROUND/DISCUSSION**

An item served before Council dated 5 December 2018 regarding the vacant position of the Executive Manager Financial Services (CFO) whereafter Council resolved as follows:

- "1. That Council takes note of the requirements for the appointment of Section 56 Managers as per the Municipal Systems Amendment Act, 2011 (Act 7 of 2011) and the Local Government: Regulations on Appointment and Conditions of Employment of Senior Managers.
- 2. That the Municipal Manager is granted permission to place the Executive Manager: Financial Services (CFO), Ms L Hoek, in the vacancy that currently exists on the organogram: Manager: BTO, Financial Statements and Assets, personal to incumbent.
- 3. That the current recruitment and selection process of the position: Manager: BTO, Financial Statements and Assets, be terminated.
- 4. That approval is granted to proceed with the advertisement of the position of Executive Manager: Financial Services (CFO).
- 5. That the Municipal Manager adhere to the provisions of Regulation 10 of the Local Government: Regulations on Appointment and Conditions of Employment of Senior Managers by advertising the post within fourteen (14) days of receipt of the approval.

- 6. That Council appoints a selection panel to make recommendations for the appointment of a candidate to the vacant senior manager position, which panel will consists of the following:
  - Municipal Manger, who will be chairperson
  - Cllr JC Lambaatjeen, member of the Mayoral Committee and head of the relevant portfolio
  - Mr A Paulse, Municipal Manager of Oudtshoorn Municipality and who has expertise in the area of the advertised post.
- 7. That Council appoints Mr J Stander as acting Executive Manager: Financial Services for a period not exceeding three (3) months to allow for the filling of the vacancy that currently exists in the position of Executive Manager: Financial Services (CFO).
- 8. That the Municipal Manager is granted permission to appoint a Service provider to assist Council with the recruitment and selection process.
- 9. That Council notes the actions that are still to be taken by the Western Cape Department of Local Government."

The practical and interviews for the position of Executive Manager Financial Services (CFO) was held on 01 February 2019 in the Gouriqua Committee Room where the Municipal Manager, Mr MG Stratu, served as the Chairperson of the recruitment and selection process for abovementioned position.

#### <u>SELECTION REPORT – CHIEF FINANCIAL OFFICER</u>

#### 1. Purpose of the Report

The purpose of this report is to note the process and outcomes of the evaluation and selection processes followed for the vacant position of Chief Financial Officer in terms of Local Government: Regulations on the Appointment and Conditions of Employment of Senior Managers Government Notice 21 in Government Gazette 37245, dated 17 January 2014 and to provide guidelines for appointment of a candidate in the advertised vacancy.

#### 2. Applicants for the Position

A total of 29 applications were received for the respective position as advertised in the National Media with closing date 11 January 2019. (See Annexure A – Advertisement & Annexure B – Long List.)

#### 3. The Selection Committee

The Selection Processes were attended by:

Mr MG Stratu - Municipal Manager Cllr JC Lambaatjeen - Portfolio Councillor

Mr AA Paulse - Expert (MM, Oudtshoorn Municipality)

Me N Klaas - Secretariate

Me A Booysen - HR: Selection & Recruitment
Mr R Dyantyi - IMATU - Observer

Mr R Steele - Facilitator.

All the participants were requested to sign declarations on confidentiality as required by law. Although both unions were invited, SAMWU did not attend the selection process.

The scores of the first three panel members were taken into consideration in the calculation of a quantitative outcome of the selection process.

#### 4. The Selection Process

#### 4.1 Method of Selection

Four candidates were shortlisted and invited to assessment and interview sessions held at the municipal offices in George on the 1<sup>st</sup> of February 2019.

The selection process consisted of the following two primary components:

- Case Study Evaluation (40% weighting); and
- ❖ A Structured Interview was administered. (Presentation and 14 competency areas interrogated – 60% weighting).

The scores derived from the above processes were combined to arrive at an aggregate score that depicts the order of performance in the assessment process, thus establishing an order of preference from where the Selection Panel is to seek consensus on the recommendation for appointment of a suitable candidate by council. It should be noted that effective measures were taken to ensure objective assessment.

#### 4.2 Chief Financial Officer

A total of four candidates were, after proper screening, invited to attend the evaluation and interview sessions for the Chief Financial Officer post. Three of the candidates attended the evaluation sessions. (See Annexure C – Short List and Annexure D - Screening Report submitted to the selection committee.)

#### 5. Outcome of the Evaluation and Interview Process

At the commencement of the selection process the Selection Panel adopted a selection procedure for the appointment of the Chief Financial Officer. The scores derived from the above processes were combined to form an aggregate score achieved by each invited candidate for the Selection Panel to consider its final recommendation. The assessment outcome may be supplemented by any valid/relevant factor or factors of a **factor evaluation** on the basis of some or all of the criteria listed in PART D of the Selection Policy to ensure that a **suitable candidate** is appointed in terms of the Local Government Municipal Systems Act.

#### 5.1 Interviews and Written Assessments

The quantitative outcome of the formal evaluation process to be considered in terms of the selection policy framework is as follows:

#### 5.3 Summary Conclusion

- 5.3.1 The selection process shows that the candidates are deemed to be competent, ranging from competent to advanced in terms of the leadership and core competencies cited in Annexure A and Annexure B of the Competency Framework.
- 5.3.2 The Selection Panel cited unanimously that Mr JvH de Jager is the most suitable candidate for appointment.

- 6.8 The Human Resources Department, as a matter of courtesy and legal requirement, inform the unsuccessful candidates formally of the outcome of the selection process, and thank them for their application and participation in the process.
