- 1 **Agreement**  
The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by the Garden Route District Municipality that his/her bid has been accepted.
- 2 **Completion of Bid Documents**
  - (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
  - (b) Bid documents may not be retyped or altered in any way.
- 3 **Alteration or Qualification of Bid**  
No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before the closure date.
- 4 **Authorised Signatory**
  - (a) A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.
  - (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.
- 5 **Submission of Bid**
  - (a) The bid must be put in a sealed envelope, or envelopes when the two-envelope system is specified, clearly marked with the bid number, title as well as closing date and time and placed in the **Tender Box at the Garden Route District Municipality by not later than 11h00 on 30 July 2021.**

Where a contract has been awarded on the strength of the information furnished by the bidder which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Garden Route District Municipality may, in addition to any other legal remedy it may have, recover from the contractor all costs, losses or damages incurred or sustained by the Municipality as a result of the award of the contract.

## **BACKGROUND/ SCOPE**

The GRDM has committed to the construction of a fire station building complex in Mossel Bay on land belonging to the district and which is identified as ERF 3803, Mossel Bay. The Chief Fire Officer will be the official responsible for the project and will ensure adherence to timelines as established for the project.

The project will take effect in the 2021/2022 budget cycle and is expected to be completed in December 2022. Occupation of the building is to be effected in March 2023. It is envisaged that the fire station complex is constructed with a modern design and with features that showcase the GRDM in a positive and developmental manner while being aware that it is being constructed with a view of expanding it in the near future to include a training academy as envisaged in the objectives of the Skills Mecca

### **Rationale**

The submission herein establishes the rationale and processes that are to be followed in ensuring the construction of the fire station in Mossel Bay while adhering to industry standards and norms. The GRDM intends to appoint a registered built environment professional as a Principal Agent to fulfil the functions of the Principal Agent for the construction of the fire station. The appointed Principal Agent is to follow the 6 stage process as provided for by the relevant professional councils in managing the project.

The essential competencies performed at each work stage relevant to the services provided are identified in all the relevant professional council's board notices for fees to be charged. Fees and disbursements will be made to the Principal Agent for work performed by each professional during the corresponding work stage. The work stages are identified as:

**Stage 1: Inception**

**Stage 2: Concept and viability (concept design)**

**Stage 3: Design Development**

**Stage 4: Documentation and procurement**

**Stage 4.1**

**Stage 4.2**

**Stage 5: Construction**

**Stage 6: Close-out**

Taking the above into consideration the GRDM intends to appoint a Principal Agent who is to serve as the overall project manager and is to ensure that the 6 work stages as captured above are performed in the required manner. During stage 4.2. the GRDM Supply Chain Management (SCM) processes will apply and will take precedence while ensuring that the technical expertise of the Principal Agent is brought into the fold.

The project in totality will encompass a two-step process whereby the Principal Agent is appointed via a tender process to perform the steps that leads to the appointment of the contractor via a separate tender process.

### **Specifications for the tender and appointment of a Principal Agent**

The principal agent to be appointed must be a registered built environment professional as defined in the specifications below. Due to the different definitions of a Principal Agent as provided for by the various built environment professional councils, it is expected that that the required professionals collaborate with each other and reach a consensus on the role of the principal agent. This collaborative effort will ensure that the bidder considers all registered professionals required for the project. In pricing the bid for the Principal Agent, cognisance must be taken of the recommendation provided for by the professional councils on the fees to be charged to perform the duties of a Principal Agent. The onus is upon the bidder to ensure that the fees are correctly priced for the different work stages.

  - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
  - 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
  - 1.7 "Day" means calendar day.
  - 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
  - 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
  - 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the provider bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.

**A PUBLIC COMPANY or SECTION 21 COMPANY**
