**1 Agreement**

The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by the Garden Route District Municipality that his/her bid has been accepted.

**2 Completion of Bid Documents**

- (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
- (b) Bid documents may not be retyped or altered in any way.

**3 Alteration or Qualification of Bid**

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before the closure date.

**4 Authorised Signatory**

- (a) A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.

**5 Submission of Bid**

- (a) The bid must be put in a sealed envelope, or envelopes when the two-envelope system is specified, clearly marked with the bid number, title as well as closing date and time and placed in the **Tender Box at the Garden Route District Municipality by not later than 11h00 on 30 November 2021.**

- Bids received in time recorded and entered in a register which is open for public inspection.

**7 Tax Clearance Certificate**

## TERMS OF REFERENCE

**TERMS OF REFERENCE – Supply, delivery of N2 gas for Air Quality sampling purposes at Garden Route District Municipality Mossel Bay Municipal Health and Environmental Services office, corner of Marlin and Sampson Street, Ext 23, Mossel Bay as well as the Oudtshoorn Monitoring station, Bongulethu clinic, Oudtshoorn**

The Garden Route District Municipality identified the need for the supply and delivery of N2 gas for two Provincial monitoring stations in Mossel Bay and Oudtshoorn. The gas is needed for air quality monitoring. Air Quality monitoring is a requirement in terms of the Air Quality Act. The stations belong to the Provincial department, but the Garden Route District has full access to the monitoring results and sample readings.

1. 2 x N2 50L/11Kg gas
2. Monthly rental for 36 months
3. Delivery and collection every 6 months over the 3-year tender period.

### 1. DELIVERY ADDRESS

Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
  - 1.7 "Day" means calendar day.
  - 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
  - 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.

## REQUIRED DOCUMENTATION

### **A PUBLIC COMPANY or SECTION 21 COMPANY**

A certified copy of the company's Certificate of Incorporation (CM3).

If any changes had occurred in the board of Shareholders or Directors of the company since registration, a certified copy of the amended Certificate of Incorporation regarding the changes that were registered in the office of the Registrar of Companies must be obtained.

*In the case of a Company, a resolution from the directors that the person who is appointed to sign the tender and SLA document is authorized to act on behalf of the Company. The full names, identity number and his/ her capacity must be included in the resolution.*

### **A CLOSE CORPORATION**

A certified copy of the Close Corporation's registration document. (CK1 & CK2).
