BID CONDITIONS AND INFORMATION

1 Agreement

The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by the Garden Route District Municipality that his/her bid has been accepted.

2 Completion of Bid Documents

- (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
- (b) Bid documents may not be retyped or altered in any way.

3 Alteration or Qualification of Bid

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before the closure date.

4 Authorised Signatory

- (a) A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.

5 Submission of Bid

- (a) The bid must be put in a sealed envelope, or envelopes when the two-envelope system is specified, clearly marked with the bid number, title as well as closing date and time and placed in the Tender Box at the Garden Route District Municipality by not later than 11h00 on 30 NOVEMBER 2021.
- (b) Faxed, e-mailed and late bids will not be accepted. Bids may be delivered by hand, by courier, or posted at the bidder's risk and must be received by the deadline specified above, irrespective of how they are sent or delivered.

6 Opening, Recording and Publications of Bids Received.

- Bids will be opened in public immediately after the bid closure date, or at such
- time as specified in the bid documents. If requested by any bidder present,
- names of the bidders, and if practical the total amount of each bid and of any alternative bids will be read out
- Bids received in time recorded and entered in a register which is open for public inspection.

7 Tax Clearance Certificate

- A valid original Tax Clearance Certificate must accompany the bid documents.
 The onus is on the bidder to ensure that the Garden Route District Municipality has an original Tax Clearance
 Certificate on record and obtain confirmation from the Supply Chain Management Unit of the Garden Route
 District Municipality.
- b. Bids not supported by a valid original Tax Clearance Certificate, as an attachment to the bid documents will be invalidated.
- c. In bids where consortia/joint ventures/sub-contractors are involved, each party must submit a separate valid original Tax Clearance Certificate.

8 Evaluation of Bids

Bids will be evaluated in terms of their responsiveness to the bid specifications and requirements as well as such additional criteria as set out in the bid documents.

9 Acceptance or Rejection of a Bids

The Garden Route District Municipality reserves the right to withdraw any invitation to submit a bid and/or to re-advertise or to reject any bid or to accept a part of it. The Garden Route District Municipality does not bind itself to accepting the lowest bid.

10 Registration on Accredited Supplier Database

It is expected of all prospective service providers who are not yet registered on the Central Supplier Database to register online (www.csd.gov.za) and verify their company information at Garden Route District Municipality Database Department. The Garden Route District Municipality reserves the right not to award proposals to prospective suppliers who are not registered on the CSD (Central Supplier Database).

12 Stamp and Other Duties

The successful bidder will be liable for all duties and costs on legal documents resulting in the establishment of a contract and for the surety and retentions.

13 Language of Contract

The contract documents will be compiled in English and the English versions of all referred documents will be taken as applicable.

14 Procurement Policy

Bids will be awarded in accordance with the Preferential Procurement Regulations, 2017 pertaining to the Preferential Procurement Policy Framework Act, No 5 of 2000.

15 Expenses Incurred in Preparation of Bid

The Garden Route District Municipality shall not be liable for any expenses incurred in the preparation and submission of the bid.

16 Wrong Information Furnished

Where a contract has been awarded on the strength of the information furnished by the bidder which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Garden Route District Municipality may, in addition to any other legal remedy it may have, recover from the contractor all costs, losses or damages incurred or sustained by the Municipality as a result of the award of the contract.

17 Validity Period

Bids shall remain valid for 120 days after the bid closure date.

18 General and Special Conditions of Contract

The General Conditions of Contract as well as any Special Conditions of Contract that may form part of this set of bid documents will be applicable to this bid in addition to the conditions of bid.

19 Municipal Rates, Taxes and Charges

The bidder to provide their municipal account of rates and taxes of both the Bidding entity and its directors' in its Bid Document submission. Any bidder which is or whose directors are in arrear with their municipal rates and taxes due to any Municipality within South Africa for more than three months and have not made an arrangement for settlement of or same before the bid closure date will be disqualified.

20 Contact with Municipality after Bid Closure Date

Bidders shall not contact the Garden Route District Municipality on any matter relating to their bid from the time of the opening of the bid to the time the contract is awarded. If a bidder wishes to bring additional information to the notice of the Garden Route District Municipality, it should do so in writing to the Garden Route District Municipality. Any effort by the firm to influence the Garden Route District Municipality in the bid evaluation, bid comparison or contract award decisions may result in the rejection of the bid.

TERMS OF REFERENCE

1. INTRODUCTION

The Garden Route District Municipality is an implementing agent for the Department of Roads and Public Works in the Western Cape. The Garden Route region currently has 680 km surfaced and 5700 km gravel roads to maintain. In order to maintain the roads, the Roads Department identified a need to appoint a service provider to supply and deliver guardrails.

2. DEFINITION

Guardrails are used to protect traffic from roadside obstacles or hazards.

3. DEMARCATION

Supply and delivery of guardrails will be at the following Road Depots:

- Mission Street, George
- > Voortrekker Street, Oudtshoorn

4. CONTRACT PERIOD

Tender period: 3 years ending June 2024.

5. SCOPE OF WORK

The supply and delivery of guardrails of the following guardrails:

- Highway Guardrails galvanised
- > Bull nose galvanised for highway guardrails
- > Splice bolts, nuts and washers
- Post bolts
- Reinforcement plates
- Reflector plates
- Guardrail timber posts
- Spacer blocks

5. SPECIAL CONDITIONS

- 5.1 Service provider must give an indication whether a part of this tender will be sub-contractor to a subsidiary or sister company. If such, only one of the entities will be allowed to tender.
- 5.2 This contract is covered under the General Conditions of Contract as contained in the tender document.
- 5.3 The service provider shall not be entitled to cede or assign any of its rights or delegate any of its obligations or duties, nor any part thereof acquired without the written consent of the district municipality.

SPECIFICATIONS

(Local Content)

- 1. <u>HIGHWAY GUARDRAILS, END WINGS, REINFORCEMENT PLATES, BOLTS, NUTS AND WASHERS</u>
- 1.1 The highway guardrails, end wings, all bolts, nuts, washers and reinforcing plates, <u>must comply in all aspects</u> with the requirements of SABS and the details shown on the drawings.
- 1.2 Although no quantities of curved guardrails are specified, service providers are required to quote extra for the cost of curving small numbers of guardrails to various radii (Refer Item 1). This information will be indicated on orders placed, where applicable.
- 1.3 Where reference is made to SABS tenderers should note that these are obtainable from the Director-General, South African Bureau of Standards, Private Bag X191, Pretoria.
- 1.4 Specifications:

The Guardrail shall conform to the requirements of the South African Bureau of Standards Specifications (latest addition (as amended).

The following additional requirements are, in terms of the specification, also itemized:

- a) Copper bearing steel is not required
- b) Rails shall have 3 slotted holes spaced at 1 905 mm centers
- c) End wings must be of the bullnose type
- d) Splice bolts, nuts and washers, post bolts and reinforcing plates are separate items under the tender.
- e) Post bolts are 300, 400 and 600mm and 16mm diameter. The thread lengths of the bolts shall be 75mm.
- f) Bolts may be supplied with either hexagonal units with washers or recessed nuts.
- g) Spacer blocks (360mmx100mmx50mm) Pine or Eucalyptus planks treated separately with Tanalith
- h) Guardrails and bullnoses shall be galvanized.
- i) Subject to normal manufacturing tolerances, the guardrail shall conform to the shape and dimensions shown on attached **STANDARD PLANS**.
- 1.5 Additional Special Conditions.
 - a) All timber posts and spacer blocks for guardrails, to comply with SABS.



General Conditions of Contract

1. Definitions

- 1. The following terms shall be interpreted as indicated:
- 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
- 1.2 "Contract" means the written agreement entered into between the purchaser and the provider, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
- 1.3 "Contract price" means the price payable to the provider under the contract for the full and proper performance of his contractual obligations.
- 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
- 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
- "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
- 1.7 "Day" means calendar day.
