# **IHS Objectives / Functions**


- To provide human settlements administration and support to address the housing needs in Bitou area
- Manage administrative processes of housing applications and provisioning to ensure proper service delivery to the community
- Render administrative support services and ensure implementation of electronic and digital application system
- Coordinate housing projects in rural areas and emergency housing provision
- To dignify the lives of the poor through provision of affordable housing, upgrading of informal settlements and servicing the farming community by promoting ownership of properties
- Research, develop and implement strategic human settlements plans

# **IHS Key Challenges**

- Housing Selection Policy was approved in 2014 and the review was done in 2021 without amendments to the existing policy
- No Human Settlements Strategy in place
- No strategy to address the middle-income home seekers
- Population growth rate of the municipality far exceeds the provision of human settlements rate (Population rate at 5.35% per annum as per the 2011 census data)
- Unavailability of developable land for human settlements



# **IHS Summary**

- Bitou Municipality seeks assistance in developing policies and strategies that will address the current human settlement challenges
- The time between application and approval must be reduced to fast track service delivery
- Eradication of informal settlements needs to be the focal point and more funding must be directed towards that goal (same strategy or even better that was used to eradicate bucket system can be used)
- The number of families using one communal toilet and standpipe needs to be revisited as it poses hygiene and health risks
