**1 Agreement**

- (b) Bid documents may not be retyped or altered in any way.

**3 Alteration or Qualification of Bid**

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before the closure date.

**4 Authorised Signatory**

- (a) ***A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.***
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.

**5 Submission of Bid**

TERMS OF REFERENCE**

## **WILDLAND FIRE JUMP SUIT / COVERALL SPECIFICATIONS**

This specification describes a jump suit and / or coverall to be used for normal operational use during vegetation and / or wildland fires.

### **1 Design :**

The design shall be as follows:

- 1.1 A one piece jump suit and / or coverall.
- 1.2 Must have a front opening, fastening with a slide fastener – it must not be fabric strip faster. Must have a fly catch at least 30 mm wide to be fitted behind the stringer of the slide fastener.
- 1.3 Must have a shirt type collar with a lapel.
- 1.4 Must have two breast pockets with angled slide fasteners.
- 1.5 Must have two side pockets in the trouser section.
- 1.7 Must have two thigh pockets at arm's length above the knee with pocket flap with Velcro or equivalent fastening.
- 1.8 Must have a pen pocket on the left shoulder sleeve.
- 1.9 Must have long set-in sleeves and must be able to roll up see 7.1
- 1.10 Must have elasticized back waist with adjustment straps see 7.2
- 1.11 The sleeves and trouser legs must be trimmed with fluorescent retro reflective tape, see paragraph 3
- 1.12 The bottom leg opening must have a slide fastener that is sufficient to fit over structural firefighting boots.
- 1.13 On both shoulders there must be straps for epaulettes and should be fastening with a button.

### **1.14 Sizes:**

The suits shall be made in six (6) standard sizes: Small, Medium, Large, Extra Large, double extra-large, triple extra-large and / or special sizes. Special size suits shall be made to fit for individual personnel, where standard sizes will not fit.

### **2. Material:**

- 2.1 The material shall consist of a blend of 65% Lensing FR/ 25% para-aramid/ 10% polyamide.
- 2.2 The weight of the material shall be 210g/m<sup>2</sup>. Grams per Square meter is the weight of the fabric if you take a sheet of material which is one meter by one meter square and weight it in grams. It is a bench mark specification to meet production manufacturing requirements

New technology makes it possible to reduce the overall weight of turnout gear – and the stress on the firefighter wearing it – without compromising heat resistance

- 2.3 It shall be woven in a rip-stop weave.
- 2.4 It must comply with the following standards:
  - EN ISO 11612:2015 for Protective clothing against heat and flames. (ISO 11612:2015 specifies performance requirements for protective clothing made from flexible materials, which are designed to protect the wearer's body, except the hands, from heat and/or flame. For protection of the wearer's head



and feet, the only items of protective clothing falling within the scope of ISO 11612:2015 are gaiters, hoods, and over boots.

The performance requirements set out in ISO 11612:2015 are applicable to protective clothing which could be worn for a wide range of end uses, where there is a need for clothing with limited flame spread properties and where the user can be exposed to radiant or convective or contact heat or to molten metal splashes.

**1. Definitions**

1. The following terms shall be interpreted as indicated:
  - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
  - 1.2 "Contract" means the written agreement entered into between the purchaser and the provider, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
  - 1.3 "Contract price" means the price payable to the provider under the contract for the full and proper performance of his contractual obligations.
  - 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of any thing of value to influence the action of a public official in the procurement process or in contract execution.
  - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
  - 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
  - 1.7 "Day" means calendar day.
  - 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
  - 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
  - 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the provider bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.
