## 1 Agreement

The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by the Garden Route District Municipality that his/her bid has been accepted.

## 2 Completion of Bid Documents

- (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
- (b) Bid documents may not be retyped or altered in any way.

#### 3 Alteration or Qualification of Bid

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before the closure date.

## 4 Authorised Signatory

- (a) A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.

## 5 Submission of Bid

- (a) The bid must be put in a sealed envelope, or envelopes when the two-envelope system is specified, clearly marked with the bid number, title as well as closing date and time and placed in the **Tender Box** at the Garden Route District Municipality by not later than 11h00 on 11 October 2022.
- (b) Faxed, e-mailed and late bids will not be accepted. Bids may be delivered by hand, by courier, or posted at the bidder's risk and must be received by the deadline specified above, irrespective of how they are sent or delivered.

## 6 Opening, Recording and Publications of Bids Received.

- Bids will be opened in public immediately after the bid closure date, or at such
- time as specified in the bid documents. If requested by any bidder present,
- names of the bidders, and if practical the total amount of each bid and of any alternative bids will be read out aloud.
- Bids received in time recorded and entered in a register which is open for public inspection.

#### 7 Tax Clearance Certificate

- a. A valid original Tax Clearance Certificate must accompany the bid documents. <u>The onus is on the bidder to ensure that the Eden District Municipality has an original Tax Clearance</u> <u>Certificate on record</u> and obtain confirmation from the Supply Chain Management Unit of the Garden Route District Municipality.
- b. Bids not supported by a valid original Tax Clearance Certificate, as an attachment to the bid documents will be invalidated.
- c. In bids where consortia/joint ventures/sub-contractors are involved, each party must submit a separate valid original Tax Clearance Certificate.

The Garden Route District Municipality reserves the right not to award proposals to prospective suppliers who are not registered on the CSD (Central Supplier Database).

#### 14 Procurement Policy

Bids will be awarded in accordance with the Preferential Procurement Regulations, 2001 pertaining to the Preferential Procurement Policy Framework Act, No 5 of 2000.

#### 15 Expenses Incurred in Preparation of Bid

The Garden Route District Municipality shall not be liable for any expenses incurred in the preparation and submission of the bid.

## 16 Wrong Information Furnished

Where a contract has been awarded on the strength of the information furnished by the bidder which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Garden Route District Municipality may, in addition to any other legal remedy it may have, recover from the contractor all costs, losses or damages incurred or sustained by the Municipality as a result of the award of the contract.

#### 17 Validity Period

Bids shall remain valid for 120 days after the bid closure date.

## 18 General and Special Conditions of Contract

The General Conditions of Contract as well as any Special Conditions of Contract that may form part of this set of bid documents will be applicable to this bid in addition to the conditions of bid.

## 19 Municipal Rates, Taxes and Charges

The bidder to provide their municipal account of rates and taxes of both the Bidding entity and its directors' in its Bid Document submission. Any bidder which is or whose directors are in arrear with their municipal rates and taxes due to any Municipality within South Africa for more than three months and have not made an arrangement for settlement of or same before the bid closure date will be disqualified.

# 1. INTRODUCTION

1.1. The Garden Route District Municipality requires suitably qualified security contractors to provide security guarding services that covers all four GRDM Resorts.

# 2. <u>SCOPE</u>

2.1. Service providers will be responsible to provide security guarding services at the 4 Resorts of the Garden Route District Municipality

2.2. Service Providers are hereby invited to tender for the provision of security guarding services at the 4 resorts of the Garden Route District Municipality.

# 3. GENERAL

## 3.1. Validity period

3.2 The tender must be valid for a period of 120 days from closing date of tender.

3.3 Service providers have the option to tender for all four resorts or chosen Resort of choice

3.4. Compulsory site meeting session should be attended by all service providers

# 4. Contract period

The contract period of Vicbay Caravan Park will commence on the 1<sup>st</sup> of October 2022 and will end on 30 September 2025

**Vicbay**: 1 October 2022 – 30 September 2025 (Night Shift Security Patrol from 18:00pm until 06:00am). For the December in season period additional day shifts guard to be appointed starting from 1 December until 15 January of each year for the duration of the contact.

## The below resorts will only be covered for the December peak season

**Swartvlei**: For the December in season period an additional day and night shift guards to be appointed starting from 1 December until 15 January of each year for the duration of the contact.

**Calitzdorp:** For the December in season period an additional day and night shift guards to be appointed starting from 15 December until 15 January of each year for the duration of the contact.

**De Hoek Mountain Resort**: For the December in season period an additional day and night shift guards to be appointed starting from 15 December until 15 January of each year for the duration of the contact.

## 5. Pricing and escalation

5.1. Prices tendered for Vicbay will be from for the period 01 October 2022 to 30 September 2025.

5.2. Prices must be fixed for the three year period and no increases will be allowed.

5.3 Each resort to receive separate invoices for the services rendered.

# 6. Professional registration

- a) Service Providers and staff members must be registered with the Private Security Industry Regulatory Authority (PSIRA). Certified proof of registration of the company and staff must accompany the tender. Failure to submit these documents with the tender will result in your bid being disqualified.
- b) Proof of PSIRA registration of all new personnel that will be deployed at the site, appointed during the duration of the contract, must be submitted to Resort Managers. It will be considered a breach of contract should it be discovered that any services within the scope of this tender is carried out by an unqualified and unregistered person.
- c) Workmen's Compensation, Registered for UIF
- d) The bidder must be COIDA compliant before the execution of any work in terms of the contractual obligations. A letter of good standing in terms of COIDA or latest assessment


