# BID CONDITIONS AND INFORMATION

# 1 Agreement

The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by the Garden Route District Municipality that his/her bid has been accepted.

# 2 Completion of Bid Documents

- (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
- (b) Bid documents may not be retyped or altered in any way.

### 3 Alteration or Qualification of Bid

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity has to be cleared with contact person for the bid before the closure date.

#### 4 Authorised Signatory

- (a) A copy of the recorded Resolution taken by the Board of Directors, members, partners or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.

#### 5 Submission of Bid

- (a) The bid must be put in a sealed envelope, or envelopes when the two-envelope system is specified, clearly marked with the bid number, title as well as closing date and time and placed in the **Tender Box at the Garden Route District Municipality by not later than 11h00 on 08 November 2022**
- (b) Faxed, e-mailed and late bids will not be accepted. Bids may be delivered by hand, by courier, or posted at the bidder's risk and must be received by the deadline specified above, irrespective of how they are sent or delivered.

# 6 Opening, Recording and Publications of Bids Received.

- Bids will be opened in public immediately after the bid closure date, or at such
- time as specified in the bid documents. If requested by any bidder present,
- names of the bidders, and if practical the total amount of each bid and of any alternative bids will be read out aloud.
- Bids received in time recorded and entered in a register which is open for public inspection.

#### 7 Tax Clearance Certificate / SARS TCS Pin

- a. A valid original Tax Clearance Certificate must accompany the bid documents with a SARS TCS Pin for independent verification of Tax status as at Bid evaluation stage.
- b. Bids submission not supported by a valid original Tax Clearance Certificate and a SARS TCS Pin will be non-compliant.
- c. Consortia / joint ventures /sub-contractors are involved; each party must submit a separate valid original Tax Clearance Certificate and SARS TCS Pin.

#### 8 Evaluation of Bids

Bids will be evaluated in terms of their responsiveness to the bid specifications and requirements as well as such additional criteria as set out in the bid documents.

The Garden Route District Municipality reserves the right not to award proposals to prospective suppliers who are not registered on the CSD (Central Supplier Database).

#### 13 Language of Contract

The contract documents will be compiled in English and the English versions of all referred documents will be taken as applicable.

#### 14 Procurement Policy

Bids will be awarded in accordance with the Preferential Procurement Policy of Garden Route District Municipality, pertaining to the Preferential Procurement Policy Framework Act, No 5 of 2000.

#### 15 Expenses Incurred in Preparation of Bid

The Garden Route District Municipality shall not be liable for any expenses incurred in the preparation and submission of the bid.

# 16 Wrong Information Furnished

Where a contract has been awarded on the strength of the information furnished by the bidder which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Garden Route District Municipality may, in addition to any other legal remedy it may have, recover from the contractor all costs, losses or damages incurred or sustained by the Municipality as a result of the award of the contract.

#### 17 Validity Period

Bids shall remain valid for 120 days after the bid closure date.

## 18 General and Special Conditions of Contract

The General Conditions of Contract as well as any Special Conditions of Contract that may form part of this set of bid documents will be applicable to this bid in addition to the conditions of bid.

#### 19 Municipal Rates, Taxes and Charges

# 1. INTRODUCTION

In order to maintain the roads, the Roads Department identified the need to appoint a service provider for the supply and delivery of CEM II cement for various projects. Service providers trading cementitious products must indicate their depot address in the price schedule.

# 2. DEMARCATION

Supply and delivery will be to the following Road Depots:

- Stores Depot, Mission Street, George
- Stores Depot, Heidelberg Road (DR1524), Riversdale
- Stores Depot, Voortrekker Street, Oudtshoorn
- > Off-loading of product to be done by service provider

# 3. SCOPE OF WORK

The supply and delivery of CEM II 42.5 Grade Cement per 50 kg pockets. Composition and strength are required to be displayed by the manufacturer on the packaging of each cement produced and must be 100% local content for cement.

Cement II 42.5 Grade must also be available for collection at the supplier's depot.

Quantity: Minimum of 100 pockets and a maximum of 500 pockets.

# 4. HEALTH AND SAFETY

Service providers must adhere to the OHS Act and Construction Regulations in terms of off-loading the product.

#### 5. DELIVERY PERIOD

Maximum period for delivery: Five (5) working days.

#### 6. PRICE

Prices must be fixed for each year over a period of three years and must be inclusive of all delivery and offloading charges.

<u>Price schedule</u>: Please note that you may only use the prescribed price schedule as provided in this tender document. No separate price schedules or lists will be accepted, except where it is specifically required.

No price increase will be accepted within the first year in multi-year tenders. Suppliers must make provisional price increment in line with inflationary forecast.

#### 7. MINIMUM REQUIREMENTS

- 7.1 100% local content for cement.
- 7.2 All the cement types in the above table must comply with the requirements of SANS 50197 or SANS 50413 and are required to have a Letter of Authority (LoA) issued by the National Regulator for Compulsory Standards (NRCS).

# 8. SPECIAL CONDITIONS

- 8.1 Service provider must provide proof of his business location (municipal account, which can be inspected at any time during the term of this contract by an official of the Garden Route District Municipality.
- 8.2 This contract is covered under the General Conditions of Contract as contained in the tender document.
- 8.3 The service provider shall not be entitled to cede or assign any of its rights or delegate any of its obligations or duties, nor any part thereof acquired without the written consent of the district municipality.




