1 Agreement

TERMS OF REFERENCE

- 1. Garden Route Municipality renders a roads agency function on behalf of the Department of Transport and Public Works. One of the main objections is vegetation management along certain main roads, divisional roads and minor roads under the jurisdiction of the Garden Route Municipality.
- 2. Service providers will be appointed for the felling of high trees which can have a hazardous impact on electrical power and telephone lines, the safety of road users and infrastructure nearby roads as well as vegetation management, where applicable.
- 3. The cutting and removing of trees can be dangerous and should be done by professionals who have been trained in safety, climbing, block and tackles, rigging and roping.
- 4. The following minimum requirements will be applicable:
 - > Experience: As per Prequalification (minimum of 1)
 - > Public liability of at least R5m (proof): As per Prequalification
 - > Registration as Pest Control Officer: As per Prequalification
 - > Chainsaw Operator Certificate: As per Prequalification
 - > Herbicide Applicator Certificate: As per Prequalification
 - Registration of workers with the Compensation Fund registration certificate must be attached to the tender document.

Failing to provide the above required certificate, bidders will deem service provider non-responsive.

- 5. The appointment of a service provider does not automatically guarantee that a project will be awarded to one service provider. Quotations for each project will be obtained from all successful service providers. Site meetings will be arranged if necessary. Site specific specifications will be provided during site meetings.
