## 1 Agreement

The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by the Garden Route District Municipality that his/her bid has been accepted.

## 2 Completion of Bid Documents

- (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
- (b) Bid documents may not be retyped or altered in any way.

## 3 Alteration or Qualification of Bid

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity must be cleared with contact person for the bid before the closure date.

## 4 Authorised Signatory

- (a) A copy of the recorded Resolution taken by the Board of Directors, members, partners, or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.

## 5 Submission of Bid

- (a) The bid must be put in a sealed envelope, or envelopes when the two-envelope system is specified, clearly marked with the bid number, title as well as closing date and time and placed in the **Tender Box** at the Garden Route District Municipality by not later than 11h00 on 27 September 2023.
- (b) Faxed, e-mailed and late bids will not be accepted. Bids may be delivered by hand, by courier, or posted at the bidder's risk and must be received by the deadline specified above, irrespective of how they are sent or delivered.

# 6 Opening, Recording and Publications of Bids Received.

- i. Bids will be opened in public immediately after the bid closure date, or at such time as specified in the bid documents.
- ii. If requested by any bidder present, names of the bidders, and if practical the total amount of each bid and of any alternative bids will be read out aloud.
- iii. Bids received in time recorded and entered in a register which is open for public inspection.

## 7 Tax Clearance Certificate / SARS TCS Pin

- i. Compulsory requirement to submit active, valid Tax Compliance Status Pin (TCS) for independent verification of Tax status as at Bid evaluation stage.
- ii. Bids submission not supported by a valid SARS TCS Pin will be non-compliant.
- iii. Consortia / joint ventures /sub-contractors are involved; each party must submit individual SARS TCS Pin.

## 8 Evaluation of Bids

Bids will be evaluated in terms of their responsiveness to the bid specifications and requirements as well as such additional criteria as set out in the bid documents.

## 9 Acceptance or Rejection of a Bids

The Garden Route District Municipality reserves the right to withdraw any invitation to submit a bid and/or to readvertise or to reject any bid or to accept a part of it. The Garden Route District Municipality does not bind itself to accepting the lowest bid.

## 10 Registration on Accredited Supplier Database

It is expected of all prospective service providers who are not yet registered on the Central Supplier Database to register online (<u>www.csd.gov.za</u>) and verify their company information at Garden Route District Municipality Database Department. The Garden Route District Municipality reserves the right not to award proposals to prospective suppliers who are not registered on the CSD (Central Supplier Database).

## 12 Stamp and Other Duties

The successful bidder will be liable for all duties and costs on legal documents resulting in the establishment of a contract and for the surety and retentions.

## 13 Language of Contract

The contract documents will be compiled in English and the English versions of all referred documents will be taken as applicable.

## 14 Procurement Policy

Bids will be awarded in accordance with the Preferential Procurement Policy of Garden Route District Municipality, pertaining to the Preferential Procurement Policy Framework Act, No 5 of 2000.

## 15 Expenses Incurred in Preparation of Bid

The Garden Route District Municipality shall not be liable for any expenses incurred in the preparation and submission of the bid.

## 16 Wrong Information Furnished

Where a contract has been awarded on the strength of the information furnished by the bidder which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Garden Route District Municipality may, in addition to any other legal remedy it may have, recover from the contractor all costs, losses or damages incurred or sustained by the Municipality as a result of the award of the contract.

## 17 Validity Period

Bids shall remain valid for 120 days after the bid closure date.

#### 18 General and Special Conditions of Contract

The General Conditions of Contract as well as any Special Conditions of Contract that may form part of this set of bid documents will be applicable to this bid in addition to the conditions of bid.

#### 19 Municipal Rates, Taxes and Charges

- i. The bidder to provide their municipal account of rates and taxes of both the Bidding entity and its directors in its Bid Document submission.
- ii. Any bidder which is or whose directors are in arrear with their municipal rates and taxes due to any Municipality within South Africa for more than three months and have not arranged for a settlement before the bid closure date will be disqualified.
- iii. Bids submission not supported by a recent municipal account will be non-compliant. In the event of leasing, a valid lease agreement <u>must</u> be attached to the bid document.
- *iv.* A Tenderer must submit a Municipal Account for their primary business location or valid lease agreement, as per address indicated in the bid document, to claim preference points for locality.
- v. Failure to submit a valid Municipal Account or Lease agreement will result in 0 preference point allocation for locality.

## 20 Contact with Municipality after Bid Closure Date

- i. Bidders shall not contact the Garden Route District Municipality on any matter relating to their bid from the time of the opening of the bid to the time the contract is awarded.
- ii. If a bidder wishes to bring additional information to the notice of the Garden District Municipality, it should do so in writing to the Garden Route District Municipality.
- iii. Any attempt by the firm to influence the Garden Route District Municipality in the bid evaluation, bid comparison or contract award decisions may result in the rejection of the bid.

## 21 B-BBEE Supplier Bid Declaration

- i. # GARDEN ROUTE DISTRICT MUNICIPALITY TERMS OF REFERENCE SUPPLY, DELIVERY AND OFF – LOADING OF GEOTEXTILES

# 1. INTRODUCTION

The purpose of the tender is to appoint a service provider for the supply, delivery and offloading of geotextiles.

# 2. DEFINITION

Synthetic polymer geotextiles of non-woven construction for use in river protection works.

# 3. DEMARCATION

Supply and delivery to the Stores in George (Mission Road), Oudtshoorn (Voortrekker Street) and Riversdale (Heidelberg Road)

# 4. PRICE

Prices must be inclusive of delivery and off-loading and be fixed for each year over a period of three years.

<u>Price schedule</u>: Please note that you may only use the prescribed price schedule as provided in this tender document. No separate price schedules or lists will be accepted, except where it is specifically required.

No price increase will be accepted within the first year in multi-year tenders. Suppliers must make provisional price increment in line with inflationary forecast.

## 5. UNITS

Only units/measurements as contained in the specifications (price schedule) must be tendered for. No alternatives will be accepted.

# 6. DELIVERY PERIOD

Seven (7) working days after an order has been issued and submitted.

# 7. MINIMUM REQUIREMENTS

7.1 A certificate of compliance not older than six months by SANS to be submitted with the tender.

# 7.2 SAMPLES COMPULSORY REQUIREMENT

A sample of each type of geotextile conforming to Grade 1 specifications as set out above offered MUST accompany the tender. Additional samples not exceeding 50 m<sup>2</sup> in area may be required for testing and shall be supplied free of charge on request.

# 1. INTRODUCTION

This specification covers the requirements for synthetic polymer geotextiles of non-woven construction for use in river protection works.

The geotextile is subject to static and dynamic loading conditions such as turbulent flow and wave action and its function is to inhibit the movement of soil particles while retaining an adequate level of permeability to prevent build-up of water pressure.

## 2. COMPOSITION AND MANUFACTURE

The geotextile shall be manufactured from a polymetric material processed into a permeable, homogeneous sheet. The tender shall specify the type of synthetic fibre and the manufacturing process. Only geotextiles of non-woven, needle punched construction are acceptable. Woven geotextiles will only be considered if published data can be provided which shows the satisfactory field performance of these geotextiles in river protection works for 15 years or longer.

Due to the temperature and moisture susceptibility of polyamide, this synthetic product is not considered acceptable.

# 3. <u>CLASSIFICATION</u>

The geotextile is required in one grade, viz., Grade 1. The grade is determined from the mechanical properties of the geotextiles, i.e., Penetration Load and Puncture Resistance. The geotextile shall also have a minimum Water percolation rate as measured in the Permeability test and a minimum mass per square metre.

NOTE: The standard atmosphere for testing and the preconditioning atmosphere for all geotextile tests (SABS test and others) shall have a relative humidity falling within the range 0 to 80 per cent and a temperature in the range of 15°C to 35°C.

# 3.1 Penetration Load

The Penetration Load at rupture shall be measured in accordance with test method 3.5 of SABS 0221-1988<sup>1.</sup> The Penetration Load of the geotextile at rupture shall comply with the following specification:

GRADE	PENETRATION Minimum

The load/elongation curve to rupture shall also be plotted.

## 3.2 Puncture Resistance

The resistance of a geotextile to puncture is the average diameter of the hole formed when a 45° cone of 1 kg mass is dropped through 500 mm on to the geotextile fixed in the holding device and shall be determined in accordance with the test method given in an appendix "Test Methods".

The Puncture Resistance of the geotextile shall comply with the following specification:

GRADE	PUNCTURE RESISTANCE Maximum
1	14 mm

# 3.3 Water Percolation

The Water Percolation shall be measured in accordance with the Permeability test method 3.7 of SABS 0221-1988<sup>1</sup>. The Water Percolation of the geotextile shall comply with the following specification:

GRADE	WATER PERCOLATION Minimum
1	20 litre/m²/s

## 3.4 Mass per Unit Area

The mass per unit area shall be measured in accordance with the Mass per Unit Area test method 3.4 of SABS 0221-1988<sup>1</sup>. The geotextile shall have a minimum mass sper unit area of 320 g/m<sup>2</sup>.

# 4. DURABILITY

A geotextile is required to comply with the following specification:

4.1 Resistance to Chemical Attack

The geotextile shall withstand the level of aggressiveness of the soil and ground water given below within significant loss of its strength and hydraulic properties during its design life of 25 years:

- 4.1.1 Soil and groundwater with a pH in the range of 4 to 12 (pH to be determined by Method A20, TMH 1, 1986).
- 4.1.2 Soil (as paste) and ground water containing salts with a conductance of up to 1,0 S/m (conductivity to determined by Method A21T, TMH 1, 1986).
- 4.2 Resistance to Ultra Violet Light

The geotextile shall maintain at least eighty per cent of its original strength after direct exposure of 1500 hours to sunlight.

4.3 Resistance to Rot

The geotextile shall be completely rot-proof and shall not support the growth of algae

## 5. <u>STANDARD DIMENSIONS</u>

The tenderer shall clearly specify in his tender for each grade the available standard widths and lengths in metres.
