1 Agreement

The successful bidder will be expected to sign the Contract Form (Part 1) of this bid document within 30 days of the date of notification by the Garden Route District Municipality that his/her bid has been accepted.

2 Completion of Bid Documents

- (a) The original bid document must be completed fully in black ink and signed by the authorised signatory to validate the proposal. All the pages must be initialled by the authorised signatory. Failure to do so may result in the invalidation of the bid.
- (b) Bid documents may not be retyped or altered in any way.

3 Alteration or Qualification of Bid

No unauthorised alteration of this set of bid documents will be allowed. Any unauthorised alteration will disqualify the proposal automatically. Any ambiguity must be cleared with contact person for the bid before the closure date.

4 Authorised Signatory

- (a) **A copy of the recorded Resolution taken by the Board of Directors, members, partners, or trustees authorising the representative to submit this bid on the bidder's behalf must be attached to the Bid Document on submission of same.**
- (b) A bid shall be eligible for consideration only if it bears the signature of the bidder or of some person duly and lawfully authorised to sign it for and on behalf of the bidder.

5 Submission of Bid

- (a) The bid must be put in a sealed envelope, or envelopes when the two-envelope system is specified, clearly marked with the bid number, title as well as closing date and time and placed in the **Tender Box at the Garden Route District Municipality by not later than 11h00 on 05 MARCH 2024.**

6 Opening, Recording and Publications of Bids Received.

- ii. If requested by any bidder present, names of the bidders, and if practical the total amount of each bid and of any alternative bids will be read out aloud.
- iii. Bids received in time recorded and entered in a register which is open for public inspection.

7 Tax Clearance Certificate / SARS TCS Pin

- 12 Stamp and Other Duties**
The successful bidder will be liable for all duties and costs on legal documents resulting in the establishment of a contract and for the surety and retentions.
- 13 Language of Contract**
The contract documents will be compiled in English and the English versions of all referred documents will be taken as applicable.
- 14 Procurement Policy**
Bids will be awarded in accordance with the Preferential Procurement Policy of Garden Route District Municipality, pertaining to the Preferential Procurement Policy Framework Act, No 5 of 2000.
- 15 Expenses Incurred in Preparation of Bid**
The Garden Route District Municipality shall not be liable for any expenses incurred in the preparation and submission of the bid.
- 16 Wrong Information Furnished**
Where a contract has been awarded on the strength of the information furnished by the bidder which, after the conclusion of the relevant agreement, is proved to have been incorrect, the Garden Route District Municipality may, in addition to any other legal remedy it may have, recover from the contractor all costs, losses or damages incurred or sustained by the Municipality as a result of the award of the contract.
- 17 Validity Period**

This document provides the Terms of Reference for a service provider/ consultant who will assist the Garden Route district in the review and development of an Air Quality Management Plan (AQMP).

A. GENERAL INFORMATION TO TENDERERS

1. INTRODUCTION

- 1.1 The Garden Route District Municipality ("GRDM") invites tenderers to submit a **Tender** for consulting services required for the review of the Garden Route 3rd Generation Air Quality Management Plan (AQMP) and the 2nd Generation AQMP's for six (6) B-Municipalities as stand-alone plans, within the reviewed Garden Route AQMP, described in the Terms of Reference included as Part B. The Tender will be the basis for a contract with the successful tenderer.
- 1.2 The review of the AQMP's shall begin no later than fifteen (15) working days after an official order are delivered to the successful tenderer.
- 1.3 Tenderers must familiarize themselves with local conditions within the Garden Route district as well as the existing assessments such as the Provincial AQMP of the Department of Environmental Affairs and Development Planning, the National Framework for Air Quality Management (2017), the Strategic Development Framework of Garden Route District municipality and consider the status quo with regards to air quality management in preparing their Tender.
- 1.4 Please note that (i) the cost of preparing the Tender and of finalizing the contract are not reimbursable as a direct cost of the development of the AQMP; (ii) Garden Route District Municipality (GRDM) is not bound to accept any of the Tenders submitted; (iii) The Garden Route District Municipality's procurement policy shall apply for awarding the tender and tenderers should acquaint themselves with this policy.

2. CLARIFICATION OF THE REQUEST FOR TENDERS

- 2.1 Tenderers may request a clarification of any of the REQUEST FOR TENDERS documents up to 24 hours before the closing date and time for tender submissions. Any request for clarification must be sent in writing by mail or electronic mail to the GRDM, to jschoeman@gardenroute.gov.za. GRDM will respond by mail or electronic mail to such request and will send copies of all responses to all tenderers who registered to obtain copies of this REQUEST FOR TENDERS.
- 2.2 At any time before the submission of Tenders, GRDM may, for any reason, whether at its own initiative or in response to a clarification requested by a tenderer, modify the REQUEST FOR TENDERS documents by making amendments. The amendment will be sent in writing by electronic mail to all registered tenderers and will be binding on

them. GRDM may at its own discretion extend the deadline of the submission of Tenders.

3. PREPARATION OF TENDER

3.1 In preparing the Tender, tenderers are expected to examine the documents comprising the REQUEST FOR TENDERS in detail, particularly the Section on:

The Terms of Reference. Incomplete or false documentation/information will result in rejection of a Tender.

3.2 While preparing the Tender, tenderers must give particular attention to the following:

- (i) If a tenderer considers that it does not have all the expertise for the development of AQMP's, it may obtain a full range of expertise by associating with individual consultant(s) and / or other tenderers or entities in a consortium, joint venture relationship, or sub-consultancy, as appropriate. This appointment will be for the cost of the consultant.
- (ii) A person awarded a contract may only enter a subcontracting arrangement with the approval of the GRDM.
- (iii) A person awarded a contract may not subcontract more than 25% of the value of the contract to any other enterprise that does not have an equal or higher B-BBEE status level of contributor than the person concerned, unless the contract is subcontracted to an EME that has the capability and ability to execute the subcontract.
- (iv) Tenders that do not meet subcontracting requirements are considered as being not acceptable tenders and must be disqualified and may not be considered for further evaluation or award.

3.3 Tender should provide the following:

4. TENDER EVALUATION

B. TERMS OF REFERENCE

1. BACKGROUND INFORMATION

In terms of section 15(2) of the National Environmental Management: Air Quality Act, 2004 (Act 39 of 2004) each municipality must include in its Integrated Development Plan (IDP), contemplated in chapter 5 of the Municipal Systems Act, an Air Quality Management Plan (AQMP).

The Constitution of the Republic of South Africa (Act 108 of 1996) provides the legal basis for allocating powers to different spheres of government and thus, institutional regulation of pollution. The Bill of Rights provides that everyone has the right to an environment that is not harmful to their health or well-being. The objectives of the National Environmental Management: Air Quality Act AQA, (Act 39 of 2004) are to protect the environment by providing reasonable measures to protect air quality and to prevent air pollution, and to give effect to Section 24 (b) of the Constitution. The AQA promotes a holistic approach of an air quality management system while the air quality management system provides a framework for managing air quality while an AQMP applies this theory in an operational manner. An AQMP is but one component of the overall Air Quality Management System.

The AQMP should be established with specific air quality goals in mind. Integration, alignment and cognizance of other policy and strategy initiatives must be taken into account.

2. PROBLEM STATEMENT

Garden Route District Municipality adopted a 3rd Generation Air Quality Management Plan in 2019, and all of the B-authorities in its jurisdiction adopted their 2nd Generation AQMP's. The National Framework proposed a review and renewal every 5 years. The renewal is now due. Each town in the Garden Route region is unique with unique air quality challenges. Air pollution has the potential to impact upon economic development in the Garden Route district. Eco-tourism is one of Garden Route's District's main economic drivers. Air quality could impact on eco-tourism in and around the Garden Route District if not managed appropriately and effectively.

3. PURPOSE

The Municipal System Act (No 32 of 2000) requires that all municipalities prepare an Integrated Development plan (IDP) through an integrated planning process to give effect to the Bill of Rights in the Constitution. The Garden Route District's IDP has identified air quality as a priority focal area. As such the AQMP will address air quality over a five year planning and financial period to align itself with the IDP.

The aim of the project is to review the Garden Route current Air Quality Management Plan and to develop a 4th generation AQMP together with the 3rd generation AQMP's for six of the

seven B- municipalities within the Garden Route District. This approach has cost saving benefits and promotes, strengthen, and improve air quality management of the seven B-authorities within the district.

The revised AQMP will provide steps towards improving and managing air quality by liaising and networking with the relevant stakeholders, collating all existing relevant air quality information, establishing a baseline assessment, and prioritizing the way forward.

The Western Cape Provincial Department of Environmental Affairs and Development planning (DEADP) encourages the alignment and integration of the anticipated.

AQMP with the various Provincial Departments and their policies, strategies, and guidelines. These include but are not limited to those relating to sustainable development, planning, energy, climate change, transportation, waste management, health, urban edge, and spatial development. It is essential that the GRDMs and the B-Municipalities AQMPs are aligned with the Provincial AQMP as well as the Strategic Development Framework (SDF) of the respective municipalities.

The Garden Route District Municipality is a Local C Authority or District Municipality. The B-municipalities within its jurisdiction are:

3. **Hessequa** – Albertinia, Still Bay, Riversdale, Heidelberg, Gouritsmond, Jongensfontein, Slangrivier and Witsand.
4. **Kannaland** – Calitzdorp, Zoar, Ladismith and Van Wyksdorp.
5. **Knysna** – Sedgfield, Karatara, Buffalo Bay, Rheenendal, The Brentons, Belvidere, Knysna and Noetzie
6. **Mossel Bay** – Boggoms Bay, Brandwag, Buisplaas, Dana Bay, Glentana, Fraaiuitsig, Friemersheim, Great Brak River, Hartenbos, Herbertsdale, Hersham, KwaNonqaba, Little Brak River, Outeniqua Beach, Reebok, Ruitersbos, Southern Cross, Tergniet and Vleesbaai.
7. **Greater Oudtshoorn** – De Rust, Dysselsdorp, Oudtshoorn and Volmoed.

Note: Kannaland is excluded as standalone plan due to budgetary constraints and their air quality management matters will be captured as part of the Garden Route AQMP.

5. GOALS OF THE PROJECT

3. Municipal Supply Regulation 38(1) prescribes that a supply chain management policy must provide measures for the combating of abuse of the supply chain management system, and must enable the accounting officer, among others, to:
 - a. take all reasonable steps to prevent such abuse;

1. Definitions

1. The following terms shall be interpreted as indicated:
 - 1.1 "Closing time" means the date and hour specified in the bidding documents for the receipt of bids.
 - 1.2 "Contract" means the written agreement entered into between the purchaser and the provider, as recorded in the contract form signed by the parties, including all attachments and appendices thereto and all documents incorporated by reference therein.
 - 1.3 "Contract price" means the price payable to the provider under the contract for the full and proper performance of his contractual obligations.
 - 1.4 "Corrupt practice" means the offering, giving, receiving, or soliciting of anything of value to influence the action of a public official in the procurement process or in contract execution.
 - 1.5 "Countervailing duties" are imposed in cases where an enterprise abroad is subsidized by its government and encouraged to market its products internationally.
 - 1.6 "Country of origin" means the place where the goods were mined, grown or produced or from which the services are supplied. Goods are produced when, through manufacturing, processing or substantial and major assembly of components, a commercially recognized new product results that is substantially different in basic characteristics or in purpose or utility from its components.
 - 1.7 "Day" means calendar day.
 - 1.8 "Delivery" means delivery in compliance of the conditions of the contract or order.
 - 1.9 "Delivery ex stock" means immediate delivery directly from stock actually on hand.
 - 1.10 "Delivery into consignees store or to his site" means delivered and unloaded in the specified store or depot or on the specified site in compliance with the conditions of the contract or order, the provider bearing all risks and charges involved until the supplies are so delivered and a valid receipt is obtained.

The National Treasury is empowered to determine the period of restriction and each case will be dealt with on its own merits. According to section 32 of the Act the Register must be open to the public. The Register can be perused on the National Treasury website.</p>
25. Anti-dumping and counter-vailing duties and rights	<p>25.1 When, after the date of bid, provisional payments are required, or anti-dumping or countervailing duties are imposed, or the amount of a provisional payment or anti-dumping or countervailing right is increased in respect of any dumped or subsidized import, the State is not liable for any amount so required or imposed, or for the amount of any such increase. 30. Governing language	<p>30.1 The contract shall be written in English. All correspondence and other documents pertaining to the contract that is exchanged by the parties shall also be written in English.</p>
31. Applicable law	<p>31.1 The contract shall be interpreted in accordance with South African laws, unless otherwise specified.</p>
32. Notices	<p>32.1 Every written acceptance of a bid shall be posted to the provider concerned by registered or certified mail and any other notice to him shall be posted by ordinary mail to the address furnished in his bid or to the address notified later by him in writing and such posting shall be deemed to be proper service of such notice.</p> <p>32.2 The time mentioned in the contract documents for performing any act after such aforesaid notice has been given, shall be reckoned from the date of posting of such notice.</p>
33. Amendment of contracts	<p>35.1 No agreement to amend or vary a contract or order or the conditions, stipulations or provisions thereof shall be valid and of any force unless such agreement to amend or vary is entered into in writing and signed by the contracting parties. Any waiver of the requirement that the agreement to amend or vary shall be in writing, shall also be in writing.</p>
