APPLICATION FOR FENCING SUBSIDY 2024 / 2025 FINANCIAL YEAR

Dear Applicant

I would like to draw your attention to the following when applying for fencing subsidy:

1. GENERAL

This scheme will be based on the policy, guidelines and type of fencing standards contained in the Provincial Roads Fencing Guide, which is provided to the Provincial Regional Offices and the District Municipalities' roads services.

2. GRANTING OF SUBSIDY

The district municipality grants a subsidy on the total estimated costs involved for the construction of a standard fence and this means in practice that it will only entail the purchase price of the material component for the type of fencing per km, according to the prices obtained on an annual basis from the local service providers and/or tenders. Labour and the cost thereof will be for the applicant.

3. APPLICATIONS

3.1 The application must be submitted to the **District Municipality, George Roads Depot** on the prescribed forms at the latest 31st May 2024 @ 12h00. The following forms must be submitted with the application:

1. Annexure B1
2. Annexure B2
3. Copy of ID of applicant
4. MBD4 form Declaration of interest

- 3.2 Subsidies will be awarded by taking the needs and distribution throughout the area into account.
- 3.3 After consideration of own identified needs (e.g. budget available, type of road involved, risks involved, etc.) the Garden Route District Municipality (Directorate: Roads), together with the Provincial Roads Authority's Regional Offices will consider and approve applications.

4. OUTCOME

- 4.1 The landowner(s) will be notified by the district municipality in writing of the outcome.
- 4.2 If the outcome is positive, the landowner will first be visited by a technical representative of the district municipality before any work may commence in order to finalize any queries regarding the process or specifications.

5. INITIAL COSTS

The landowner initially bears all the costs for purchasing the fencing material (according to the prescribed specifications of the Provincial Roads Authority) as well as the construction costs. Proof of purchases of all material must be submitted before any payment will be made to the applicant.

6. COMPLETION PERIOD

A completion period of two (2) months from the date of approval of an application will be maintained (before 30 November of each year).

7. INSPECTION OF COMPLETED WORK

An inspection will take place after completion to confirm whether the work was done or not, and according to prescribed standards, after inspection and approval of the fence a payment will be made to the landowner.

8. APPROVAL OF APPLICATIONS

Authorization is granted to the Municipal Manager and Executive Manager: Roads to approve applications where after a contract will be signed by both parties.

9. NON CONFORMANCE

With non-conformance no subsidy will be paid and it will disqualify any applicant for a period of 2 years for new applications.
