Foot-and-Mouth Disease Update 17: Garden Route District Municipality Multi-Agency Command Centre on 28 April 2026 at 14h00

Joint Statement: Garden Route DM, Western Cape Government and Agri Western Cape

FMD STATS: GARDEN ROUTE

Affected municipal area:	Mossel Bay
FMD-affected farms (officially confirmed):	7 (no increase)
FMD-suspect site(s), pending test results:	1 (still awaiting results)
FMD-tests returned negative:	25 (increased with 8)
Number of farms vaccinated:	234 (Increased with 22)
FMD-Vaccines administered to date:	51 365 (Increased with 5 290)
Livestock infected:	Cattle
Number of Vehicle Control Points around quarantined area:	7 static and 4 roaming

1. The Garden Route is home to 141 850 cattle.
2. There are 29 private veterinarians registered in the Western Cape to administer FMD vaccines.
3. All quarantined areas were vaccinated.
4. Of the 15 000 vaccines received for the Western Cape, most are allocated to private vets and dairy farms.
5. The only Local Municipal area affected by the FMD outbreak remains Mossel Bay and to date all suspect farms could be traced back to the index farm in the Hartenbos area.
